

#### The continuing saga of our 5.19 repeater.

We have purchased an isolator as discussed, it has arrived and been installed on the system. A week later, we fine tuned the cavity set as well as the isolator with a sweeping real time spectrum analyzer. We found the BP/BR duplexer to be out of adjustment on both reject paths. Now we are sporting about -91dB of rejection.

On the down side, we still have a corroded joint of some type radiating spooge. It appears to be getting worse (stronger) causing some desense to operators using the machine. This has prompted me to shut the tx down during these high spooge events, in order to protect the amp. The Timeout timer is largely ineffective in combating this problem due to the sporadic nature of the signal. Additionally, it seems as though this mixing is aggravated or (helped) as the case may be by our transmitter output.

The cost of applying for an amateur vanity call sign is expected to rise slightly this fall. In a just-released Notice of Proposed Rulemaking involving assessment and collection of regulatory fees for Fiscal Year 1999 (MD Docket 98-200), the FCC has proposed increasing the vanity fee to \$1.42 per year or \$14.20 for the 10- year term.

The current vanity fee is \$13. That figure, originally proposed at \$1.29 per year (or \$12.90 for the 10-year term) was "rounded up" to \$1.30 per year by the FCC when it was implemented last fall, so it's possible the FCC might adjust the final number up or down to an even dollar figure this time as well. The FCC projects 6800 vanity applications in FY 1999 for a total revenue figure of more than \$96,000.

The vanity call sign business has continued to be brisk over the past year and picked up slightly after the vanity call sign fee dropped from its high of \$50 to \$13 last September. The FCC reports it received a total of 12,152 vanity applications during 1998--slightly more than 1000 a month; however, not all applications have resulted in call sign grants. That trend continued in January and February. The FCC got more than 1400 applications in each of those two months.

The vast majority of applications last year were filed electronically. The FCC reports that fewer than 20% of last year's applications arrived on paper. The Commission's Gettysburg office currently takes approximately three weeks to process a vanity call sign application.

#### Why are Radio Amateurs called "HAMS"? From Florida Skip Magazine - 1959

Have you ever wondered why radio amateurs are called "HAMS"? Well, it goes like this: The word "HAM" as applied to 1908 was the station CALL of the first amateur wireless stations operated by some amateurs of the Harvard Radio Club. They were ALBERT S. HYMAN, BOB ALMY and POOGIE MURRAY.

At first they called their station "HYMAN-ALMY-MURRAY". Tapping out such a long name in code soon became tiresome and called for a revision. They changed it to "HY-AL-MU", using the first two letters of each of their names. Early in 1901 some confusion resulted between signals from amateur wireless station "HYALMU" and a Mexican ship named "HYALMO". They then decided to use only the first letter of each name, and the station CALL became "HAM".

In the early pioneer days of unregulated radio amateur operators picked their own frequency and call-letters. Then, as now, some amateurs had better signals than commercial stations. The resulting interference came to the attention of congressional committees in Washington and Congress gave much time to proposed legislation designed to critically limit amateur radio activity.

In 1911, ALBERT HYMAN chose the controversial WIRELESS REGULATION BILL as the topic for his Thesis at Harvard. His instructor insisted that a copy be sent to Senator DAVID I. WALSH, a member of one of the committees hearing the Bill. The Senator was so impressed with the thesis is that he asked HYMAN to appear before the committee.

ALBERT HYMAN took the stand and described how the little station was built and almost cried when he told the crowded committee room that if the BILL went through that they would have to close down the station because they could not afford the license fees and all the other requirements which the BILL imposed on amateur stations.

Congressional debate began on the WIRELESS REGULATION BILL and little station "HAM" became the symbol for all the little amateur stations in the country crying to be saved from the menace and greed of the big commercial stations who didn't want them around. The BILL finally got to the floor of Congress and every speaker talked about the "...poor little station HAM". That's how it all started. You will find the whole story in the Congressional Record.

Nation-wide publicity associated station "HAM" with amateur radio operators. From that day to this, and probably until the end of time in radio an amateur is a "HAM"

**Those** interested in radio/TV history should read Mark McGuire's excellent article on page A3 of the Times Union for Sunday, March 21. It's title is "1928: Birth of Television." It describes the humble beginnings of household television, transmitted by W2XB. (We do not think the "W" was part of the callsign in 1928, but that's unimportant.)

Mark McGuire very correctly states that the designation "Father of Television" belongs to several inventors. The July 1925 issue of QST describes a very crude version of television that was invented by C. Francis Jenkins (who also invented telephotography, the radio-transmission of still pictures). Jenkins didn't use UHF. He didn't use VHF. He used a carrier frequency of 1.875 MHz (in today's 160-m band)! Sent in by Bob,W2XM
