FCC to Require Email Addresses on Applications

12/02/2020

Amateur radio licensees and candidates will have to provide the FCC with an email address on applications, effective sometime in mid-2021. If no email address is included, the FCC may dismiss the application as defective.

The FCC is fully transitioning to electronic correspondence and will no longer print or provide wireless licensees with hard-copy authorizations or registrations by mail.

A Report and Order (R&O) on "Completing the Transition to Electronic Filing, Licenses and Authorizations, and Correspondence in the Wireless Radio Services" in WT Docket 19-212 was adopted on September 16. The new rules will go into effect 6 months after publication in the Federal Register, which hasn't happened yet, but the FCC is already strongly encouraging applicants to provide an email address. When an email address is provided, licensees will receive an official electronic copy of their licensees when the application is granted.

Under Section 97.21 of the new rules, a person holding a valid amateur station license "must apply to the FCC for a modification of the license grant as necessary to show the correct mailing and email address, licensee name, club name, license trustee name, or license custodian name." For a club or military recreation station license, the application must be presented in document form to a club station call sign administrator who must submit the information to the FCC in an electronic batch file.

Under new Section 97.23, each license will have to show the grantee's correct name, mailing address, and email address. "The email address must be an address where the grantee can receive electronic correspondence," the amended rule will state. "Revocation of the station license or suspension of the operator license may result when correspondence from the FCC is returned as undeliverable because the grantee failed to provide the correct email address."

{Comment from N2ADD: I am not sure that existing licensees will have to provide an email address before renewing or modifying a license or, if that is required, the procedure for doing so.}



Article XII, Sect. 2

No more than three of the Board of Directors positions may be held by Technician Class licensees.


Article XIV, Sect. 3

Proposed wording:

Nominations for Members of the Board of Directors shall take place at the regularly scheduled November and December meetings.


Spotting Networks

WSJT-X, JS8Call and FLDIGI all include an optional **spotting network** feature. This is a fantastic system for the technical ham. When enabled, these programs will monitor all traffic received and forward signal spotting reports via the internet to a central database.

You can access this data from sites like https://pskreporter.info. With that information, you, working alone, can see how well your signal is getting out. Other stations receiving your signal will forward a spot report, even if the operator isn't answering calls. This can save you loads of time while troubleshooting your rig and antenna, and the benefits of working this way can help you reach further and sound better on any mode.

So what do you do with it?

One of the simplest things you can do is fire up WSJT-X, pick a band and slot for your transmission and call CQ a few times. (if you catch somebody, work it!) Then sit back and wait a few minutes.

Spot reporting is entirely volunteer-driven and internet-hosted, thus it may take a few minutes for the data to make it from reception points to the database, and then into pskreporter for display.

After a few minutes, point your browser at https://pskreporter.info/pskmap.html

Enter your callsign into the search query at the top of the page, and let it process. You should be greeted with a map showing you all of the stations that received and reported your callsign, along with a timing indicator to tell you how long ago the call was heard. This timing info can help you distinguish between before/after action in tuning an antenna or adjusting radio settings.

This tool, in conjuction with WSJT-X can let one ham working alone make great use of his or her time in troubleshooting and tuning the station. A timesaver like this can really help a busy ham stay active and connected!

Another spotting network is "https://hamspots.net" to help you find current digital activity on any band or mode. Sites like these can save you a lot of time when you want to operate digital, but aren't sure which modes are on the air that day.


- 13. Scott Scheirer, KC3PCS, is sending out our RRC Meeting (live stream) to those who cannot attend our meetings.

Check into the <u>RRC MEETING ON THE AIR</u> on the Friday evenings that we do not have an in-person meeting. The net, on 146.91 MHz, starts at 8:00 p.m. with the latest AMATEUR RADIO NEWSLINE RE-PORT from the West Coast.

We then have an exchange of information that may be of interest to the members of the Reading Radio Club as well as those that are not RRC members.

The last part of the net is a roll call where we usually have 13 to 56 stations check-in and test their FM two-meter analog equipment.

The Continuous Tone Coded Squelch System, (CTCSS) frequency is 131.8 Hertz (3B). The CTCSS is often referred to as "PL" (Motorola's trade name) or "Channel Guard" (GE/Ericsson's trade name).

The net has been in operation since Friday January 21, 1994, when we had 13 check-ins during that first session, 27 years ago.

On Friday December 18, 2020, we had session number 1143. Jim Nicholas, W3ITH, was the Net Control.

No Reading Radio Club Meeting On The Air was scheduled for Christmas, Friday December 25, 2020.

The Editor of the February 1971 READING RADIO CLUB BULLETIN was William "Bill" Ader, WA3GTR, (SK).

The following is, in a large part, the republishing of the "Highlights" of the January 8, 1971, monthly meeting taken from the February 1971 issue of the RRC BULLETIN, and written by the RRC Secretary Al Brailer, W3UQC, (SK). Other information has been added that has been taken from the RRC BULLETIN, personal notes, and meeting agendas.

The Friday January 8, 1971, monthly meeting was held in the UGI "Flame Room" Auditorium at 225 Morgantown Road, Reading, Pennsylvania.

RRC President Rich Ahrens, W3WJC, opened the meeting at 8:00 p.m.

The January 8, 1971 monthly meeting was attended by 36 RRC members and four guests.

The winner of the door prize was RRC President Rich Ahrens, W3WJC.

President Rich Ahrens, W3WJC, introduced Rian Robison, W3EMW, from the small town of Gouglersville, Pennsylvania. Rian, W3EMW, is an Electronic Maintenance Technician working for the Sunoco Pipeline Company. Rian, W3EMW, has been involved with bringing the RRC 6 Meter Repeater Transmitter System up and running at the Deer Path site.

Rich, W3WJC, said that the RRC 6-Meter Repeater is in operation. The receiver, on 52.575 MHz, is located at the WEEU site on Mt. Penn (N 40° 21′ 16″ W 75° 53′ 57″) and the transmitter, on 52.640 MHz is presently located in his residence at 3404 Reading Crest Avenue, Muhlenberg Township. The repeater sports the W3CCH Call Sign.

Rich went on to say that at the Friday February 12, 1971 monthly meeting a demonstration of the 6-Meter Repeater will be conducted.

President Rich, W3WJC, congratulated Adrian Adkins, WA3NHI, on taking the trip to the Philadelphia Custom's House on December 29, 1970 and passing his General Class FCC exam. Adrian said that next year he is going to take the Advanced. Adrian had held the Technician license for many years but decided to upgrade with the Extra Class License his goal. Best of luck to Adrian.

Rich, W3WJC, read a cordial letter from our good friends at the Phil-Mont Mobile Radio Club, Inc., down Philadelphia way. They are extending an invite to other clubs to attend their March 1, 1971 meeting at The Franklin Institute Science Museum. The Institute has offered to have an evening sky show in the Planetarium for Phil-Mont members and their guests. Rich, W3WJC, asked the members to let him know at the February 12, 1971 meeting if you are interested in attending this Phil-Mont get-together. We will try and organize several carpools.

President Rich Ahrens, W3WJC, discussed the Federal Communications Commission's fee schedule. He said that there has been a lot of misunderstanding. Rich outlined the FCC fee schedule:

Modification of a license without renewal is \$4.00

Modification with renewal is \$9.00

Renewal only is \$9.00

A Special Call Sign is \$25.00

Novice License is free & is non-renewable for a two-year term.

Rich, W3WJC, announced that Novice Code and Theory Classes are being held at the Wilson High School under the direction of Bob Plummer, W3ETJ / W3RP, and that presently there are twelve in the Code Class and three in the Theory Class. It is expected that the FCC Novice Exams will be given around the end of January 1971.

Rich, W3WJC, reported information from a recent ARRL survey of 575 Amateur Radio Clubs. The ARRL reported that the average club has 34 members and that 17 members attend the meetings. The average dues is \$7.45 per year. The survey revealed that the average club is down in both membership and attendance, and that annual dues are going up. The survey also showed that the use of FM is on the increase and that SSB is holding its own at 44 percent. Rich said he thought the RRC was doing much better than the "Average" Amateur Radio Club.
