## VIII. New Business

President George Tippett WB5PKK presented the three proposals made by the Board of Directors to amend Section 26 of the By-laws of the Society. Section 26 addresses the distribution of information on By-Laws, conflict of interest policy, financial documents, and annual IRS filings.

Motion: Amend the previous motion to include the phrase "free of charge upon request pending Board approval" to the end of Article 2.(KK5CM/KF5NSM)

Motion: Call the question on the previous motion and amendment. (KI5BNZ/KF5UJA)

Voting approved the amendment and the motion as amended. The three approved modifications of the By-Laws are the following:

- 1. Replace Article 2: Financial and IRS documents...BAYOU REGION AMATEUR RADIO SOCIETY, INC. shall provide copies of bylaws, conflict of interest policy, and financial documents free of charge upon request pending Board approval.
- 2. Delete Article 3 in its entirety.
- 3. Replace Article 4: IRS Annual information Returns...BAYOU REGION AMATEUR RADIO SOCIETY, INC. shall report IRS filings to the Board of Directors.
- IX. Demonstration and Discussion of Wires-X on Theriot (147.300)

  President George Tippett WB5PKK initiated informing the members present the presence of the Wires-X on the 147.300 System Fusion repeater. He presented Craig Matheny KK5CM who gave a welcomed presentation of the digital systems in place. Considerable instruction and discussion on the digital systems and DWARN (Digital Wide Area Repeater Network) followed. No club action was taken.
