Speaking of erecting antenna's. Tom Vroman N2BGM and myself have installed two 2 meter beams at the shack on the east 30 foot tower. One beam is vertically polarized and the other is horizontally polarized

One problem is we have to lower the tower back down to check the rotor that was working before we raised the tower. Also one coax needs to be extended to reach inside the building. With any luck we can get this done the weekend of 6/11-6/12 to be ready for Field Day Weekend.

Meeting called to order at 7:41 p.m. by President,

Secretaries Report:

Paul (N2NCB), made the motion to accept the March 2, 2010 Secretaries Report as printed. Warren (KC2NGR) seconded the motion. It voted on and passed.

Treasurer's Report:

Treasurer's Report was read and explained.

Vinnie (N1JPM) made a motion to accept the Treasure's Report as presented. Warren (KC2NGR) seconded the motion. It voted on and passed.

Committee Reports:

Fundraising- Nothing to report on this month.

Programs- John (WB2FQZ) lead for a person from the airport has fallen through. They're shorthanded and unable to assign anyone. The railroad department will not grant permission for their personnel to come to talk to us. So he is out of ideas. Can people please come up with some ideas that you would like to see for programs? John (WB2FQZ) would gladly look around to see if he can find someone to come and speak. Nevertheless, he has not a clue what people would like to see.

W2OW Shack- John Rudy (WB2FQZ) mentioned that the shack area needed mowing. Stan Progy (W2EWM) usually does it but because his age and health no one was sure if that would be possible anymore. John (WB2FQZ) said he would swing by and inquire. He also said that the shack was in fine shape after all the bad weather last week.

Brian (K2DLB) brought up that he and Tom (N2BGM) have been working up at the shack and have put up a pair of 2 meter beams on the short tower in the back of the shack last weekend. The rotor worked well before standing the tower but after getting it back up, it did not work. So some weekend coming up they will go back up and take it down and fix it. So there will be a set of 2 meter beams available for anyone if they want to use it.

Old Business:

Field Day June 25 & 26 2011- Lee Savidge (W3EFE) talked about that he has been with contact with the local Boy Scout troops in the Binghamton area and mentioned that at this time, there were 20 or so Boy Scouts planning to camp out and meet with Tom Siglin (WA2LTD) to work on their Amateur Radio Merit Badge. He also said that the local Cubs Scouts and Girl Scouts expressed an interest in coming up as well to observe and learn about Amateur Radios in addition. The Boy scouts are planning to make it an overnighter. He wanted to make sure that there were going to be people around to help show all of these young people about HAM Radio. Their main interest was a demonstration on working the different satellites that HAM's use. Lee (W3EFE) said that we did not have to entertain them; they will take care of themselves. However, we have not found anyone that does this mode available as of yet. He also wanted to make sure that there would be a porta-potty. John Rudy (WB2FQZ) said that the Porta Potty is on order.

Fellow Amateur Radio Operators,

If you don't subscribe to CQ magazine, in the April Issue (pg 28) is an article that is a bit disturbing. The article was written by Professor Emil Heisseluft who is currently in Geneva, Switzerland, consulting with his European colleagues at the Large Hadron Collider on his specialty, the Higgs bosom. Professor Heisseluft obtained this information while on a trip to Washington, DC and the halls of congress.

I will give you a short recap.

Draconian cuts in the federal budget for FY2012 portend significant staffing cuts in the FCC that will drastically impact the Amateur Radio and Amateur Satellite Services. Among other things, operators using the 160-6 meter bands will be limited to operating on odd or even days of the week, depending on the numeral in their callsign. If the number is even you get even numbered days and odd, odd number days.

New-issue vanity callsigns will become a thing of the past along with special event callsigns. The wait time for reissuance of a callsign for a "Silent Key" will be extended from two to five years.

This will be imposed without the usual Notice of Proposed Rule Making because of the emergency nature of the matter.

Interesting. When this goes into effect I would not be able to talk to another Ham Radio Operator in the U.S. with an odd

callsign. Emergency communications on HF would become a problem along with HF net activities and so on. From AB4AL

Technician Class T1A10 - What is the FCC Part 97 definition of an amateur station?
