## **The President's Corner**

**Have You Tried VHF/UHF Simplex?** When I first started using the VHF/UHF bands, I used a borrowed tube type, 6-meter AM rig. There were a lot of other hams in the Doylestown, PA area also working 6-meter AM on 52.525 MHz. When I was home, I would turn on the rig and monitor. Eventually a mobile or fixed station would call, there would be a few replies, and a "round table" would ensue. Although we had no repeaters there was still a lot of activity and it was pretty easy to make a VHF contact. There were no time-out timers and we could — and did — talk as long as we wanted. We also monitored several 10-meter frequencies and worked stations on 10-meter AM for distances of 15-20 miles.

Years later I moved to Liverpool, NY and with other hams formed the Liverpool Amateur Radio Club (LARC). We put a repeater up on 31/91, but many club members still operated simplex on 146.52 or 146.55. It was an effective way to keep track of friends: We could carry on long conversations without worrying about repeater timeouts, and we knew our friends were always monitoring the simplex frequencies.

**Listening to the VHF/UHF bands** in the Binghamton Area, it appears to me that operators using the bands above 50MHZ are much too dependent on repeaters and should consider establishing some simplex frequencies on which to contact their friends from out of town. For example, why not monitor a frequency such as 146.52 and tell everyone that you are monitoring this frequency? If someone is mobile and starts to get out of range, you can then switch to a repeater frequency.

**Think about a severe weather emergency** — an emergency that takes out power lines. If this happens, most repeaters will go off the air and simplex operation will become a necessity if you are to be of any help in the emergency. Take time now to find out just how far your rig will go when operating simplex. — *DE*

## **Proposed Change to the BARA Constitution**

At the General Meeting in September BARA will vote on a change to the Club Constitution that makes the Club Officers (President, Vice President, Secretary, and Treasurer) Members of the BARA Board. This change would permit the Board to conduct business with a quorum of five members. It addresses problems with the present arrangement where the absence of two or more Board Members prevents any action by the Board. Under the existing constitutional provisions the only Officer who can vote is the President and he can only vote to break a tie.

## **Update on the Milks Property**

As many members are aware the Milks family has approached the Club and requested that we make an offer on the Shack Property. The Officers and Board (as authorized by a vote of the Membership at the June General Meeting) are in the process of developing an offer which, if accepted, would be contingent on a vote of the Membership at a General Meeting.

A decision to make an offer on the property and commit the Club's resources is not one that should be taken lightly and all Members should have an opportunity to make their views known. The Shack is a great resource and over the years it has been the focus of many BARA Activities. Our Antenna Farm and Operating Setup are superb. Some of the funding for the Shack was provided by the Club, but an equal — even a greater — amount has been donated by Individual Club Members making the Shack truly a Group Undertaking that is open to all members. On the other hand, It might be argued that buying the property would over-commit the Club. In the end it is you — the BARA Membership — who will decide and we ask each member to seriously consider this question and to come to the Board and General Meetings to comment.

Finally, with the possibility of a change in our status on the Hilltop the Officers and Board have deferred any action on the replacement of our existing Tower. If conditions warrant, the existing structure will be removed, but no new construction will take place until all issues surrounding the property are settled.

### **WSKG Tower**

Progress continues in the negotiations to transfer the old WSKG Tower and Property in the woods behind the BARA Shack from WSKG to BARA. Inquiries about this tower were initiated several months ago and WSKG has responded in a positive way by offering to give the site and structures to BARA for the cost of the legal work.

Although the area is too small for any extensive Operating Positions the tower is a solid structure and might serve well as a Repeater Site or an additional HF Antenna location.

### **Skywarn Notes**

In late May/early June Scott Bauer, W2LC, our Western New York Section Manager announced some structural changes to the Regional SKYWARN organization.

Overall operations are the responsibility of the Skywarn Executive Committee consisting of two people from the National Weather Service, the Eastern Pennsylvania Section Manager and the Western New York Section Manager. The Section Managers have the option of appointing a representative to the Executive committee.

A Skywarn Advisory Committee will support the Executive Committee. Two National Weather Service people, an Amateur Radio Skywarn Coordinator and the Section Emergency Coordinators for Western New York and Eastern Pennsylvania compose the Advisory Committee. The Emergency Coordinators have the option of designating representatives.

The Amateur Radio Skywarn Coordinator will be appointed by the Western New York Section Manager as one of the Emergency Coordinators within the ARRL Western New York Field Organization. He or She will have no county or regional duties, but will specialize as "Amateur Radio Skywarn Coordinator for the Binghamton National Weather Service". The Coordinator does not have to be an ARRL Member. To assure accountability the Coordinator will report to the Section Managers and Emergency Coordinators on the Executive

### **Video Review — Radio Days**

If Garrison Keillor's "Prairie Home Companion" introduced a new generation to the magic of live radio, it can be said that Woody Allen's "Radio Days" reminded that generation of just how the magic box colored our lives in the twentieth century.

Not so much a plotted story as a series of vignettes, "Radio Days" weaves snippets of stories about radio personalities and events with the trials and tribulations of a young Jewish boy growing up in New Jersey and his extended family. Sometimes hilarious and sometimes bittersweet the movie has, throughout, the stamp of honest affection for family and for the memories tuned by the glowing dial. Nicest (and most memorable) are the voices: the magic, haunting, voices of the performers "on the other side" of the dial. Some of the performers are actual personalities from the Golden Age and the nuance and rhythm of their voices works its magic and reminds one that Radio is truly better because the pictures are "all inside your head".

"Radio Days" is available on DVD and may, with luck, be found in the VHS format as well.
