President's Corner September 2010

This past month I had the pleasure of visiting the the BARA shack to operate for an afternoon. For those of you who weren't aware, BARA members enjoy use ham shack located on a scenic hilltop off Milks Road in Vestal. The shack is outfitted with a Kenwood transceiver, a tri-band beam antenna with rotor atop a tower, a dipole antenna, and a PC. The site is gorgeous – I spent part of my afternoon picking lush ripe blackberries adjacent to the shack.

I find the BARA shack site to be far superior to my home in the valley. With my "slinky" dipole, I struggle to achieve DX (I usually have to resort to CW or digital modes), but up on the hill, the same 100 watt power gives me a clear voice into Europe. I had previously received awesome signal reports from European SSB stations; that day I contacted Siena, Italy and Paraguay (South America). I also copied a couple of Slow-Scan TV signals (I'm submitting these to our editor in hopes that we will be able to reproduce them in color in the online version of the BARA Facts) using software and an audio interface I've provided. I will soon be purchasing a PC interface (USB-based) so that we can expand our digital capabilities there, and be able to send (not just receive) using SSTV and other digital modes.

Your membership dues are supporting use and maintenance of the shack, which is available for use by all BARA members. If you are interested in using the shack, contact myself or any of the Officers listed on the last page of this newsletter for information.

You are free to use your own callsign, or else you can use the club call (W2OW). If you decide to use the club callsign, Mel (WE2K), our Trustee, has established the following guidelines:

- Operators must remain within the bands allocated to the class of license they hold – using the W2OW callsign does *not* grant privileges outside one's designated limits.
- BARA members can also use the W2OW callsign from home (during, for example, contests), but permission must first be secured from Mel.

Anyone under the age of 18 should be accompanied by an adult when using the BARA shack.

The next activity planned up at the shack is Jamboree on the Air, during the weekend of October 16-17 (this is also the weekend of the NY QSO Party, so the airwaves should be jumping!). As we did this past Field Day, we will again have a portable toilet onsite to facilitate long-term use of the shack. I am working with a couple of co-workers to ensure that we have a few local Boy Scouts participating this year. Weather permitting, we will camp out up on the hilltop. If you would like to be involved, please let me know!

Tower Power

Once upon a time the shack did not have commercial electric power. Way back then, the early 60's power was obtained from various small personal generators when needed. The "dog house", about ten feet in the woods on the North side of the shack, housed a small gasoline generator. One night it grew legs and walked away. Shortly thereafter the club was blessed with a Military Model PE-95-K generator. It used a Willy's CJ-3A gas engine. At full load it cranked out 10,000 watts. It was rated at 85 amps at 118 Volts, 60 cycle. This baby was placed on railroad ties on the South side of the shack and was housed in a utility shed type enclosure. I can still remember the day it was delivered. I was a relatively new member of BARA at that time. Just a kid of 24 +/-. Jim Salisbury, W2OKA, transported the generator in his pickup to the hilltop. Some number of us were waiting to off load. He backed up to the bed of railroad ties and using pipes etc the big machine was leveraged and shoved off the truck. "KAPLOW", it landed smack dab in the middle of the ties. No further adjustment in position had to be made. The shed was then built around it. I don't know who or how the generator was loaded on the truck. It was "acquired" from the Central Fire Station in Binghamton for a very reasonable price. Did I mention that Fred Frieberg, WA2MSQ, a member of BARA, happened to be BFD Fire Chief. Oh, that Willy's engine sounded great. As I recall it has less than thirty hours on the elapsed time meter when it was delivered. Good thing it had crank start capabilities in addition to electric start. The battery didn't hold up well in the January cold for the VHF contest or the many winter, every week, 11 AM Sunday morning 6 meter net operations run from the shack. The generator loved the gas. The contents of the 6.5 gallon tank seemed to almost evaporate. Even at \$0.24 per gallon it was expensive to run the "big" machine. Fuel acquisition and storage were problematic. We were then blessed with two 1.5 KW generators from the same benefactor. These worked fine for single equipment operations. The "big" machine was used for contests. One of the small generators wandered off over the years. The second is "out of service" and still accountable at a member's location.

One day, the club received and odd request. A representative from BOCES (Board Of Cooperative

Education Services) made inquiry wondering if the club would be interested in petitioning the electric utility company (NYSE&G) to run electricity to both the intended BOCES tower site and the shack. BOCES wished to build the 97 foot tower with a TV translator at it's base and rebroadcast educational programs to the school on Saddlemire Road. If two entities petitioned the utility for service and the primary line was within 1500 feet then the utility would have to be positive in their reply. Well, as my faded (or jaded) memory recalls, the measurements were made and the utility started the construction project. Oh, did I mention that the chap who did the tape measure work for the utility was a HAM. All was going well until the construction proved quite difficult. Drilling equipment became stuck a number of times in the rock up cropping, etc. About this time, a second call from BOCES indicated that the project would now be a partial "cost share" project and BARA's share would be about \$4,000. Needless to say BARA would not be able to cover such an expense. To make a long story short, I understand BOCES ended up paying Both shares, ours and theirs. And so, without much fan fare, the hilltop acquired commercial electric power. What happened to the PE-95-K? Well, it was sold, for \$800, to a race track for their use for emergency power in April 1984. Elapsed time on the operating meter, 125 hours. So now you almost know the rest of the story.
