Illinois QSO Party To Be Held On Sunday Oct. 20

A Quick Summary:

The Illinois QSO Party is an 8-hour event, usually held on the third Sunday in October. The event is open to all amateur radio operators. The event uses 160 meters through 2 meters. CW contacts count 2 points each, while Phone contacts count I point each. Stations are divided into two groups: Illinois stations and non -Illinois stations. Stations inside IL try to work IL counties, states, and countries as multipliers. Stations outside IL try to

work IL counties as multipliers. IL stations are further divided into fixed, mobile, or portable.

The QSO party begins at 17:00 Z on the 20th and will continue to 01:00 Z on the 21st. IL ops exchange RST and county. Outside of IL ops give RST, state, province for country.

There are five entry classes:

IL Fixed, IL portable, IL mobile, IL Rover, Outside IL. The difference between mobile and rover is that a rover will travel to many different counties;

whereas, a mobile station will travel to another county and operate from there.

This promises to be a fun event and it is a good test of emergency preparedness! Let's make this a club effort and let's put K9MCE on the IL QSO Party map!!!

**The League has filed reply comments in an FCC NPRM which proposes to allow private telecommunication certification bodies (TCB) more authority in the equipment

authority in the equipment authorization process. For those who came in late, RF devices generally require some kind of certification or

another. Part 15 covers unlicensed devices and incidental radiators.

Part 90 deals with private land mobile stuff, and on. The exception is

the Amateur Radio Service. Contrary to popular opinion and Philadelphia

lawyers, there is no required certification for Amateur equipment except mass produced RF power am-

mass produced RF power amplifiers (47 CFR 97.315(a)). All of that said,

the League is against granting any more authority to these TCBs, as they

are over-trusted at this stage of the game, and bad things happen under

the guise of certification. An example cited was the debacle of the

Recon Scout, the 70's vintage surveillance technology that was plopped

into the 70cm band without a lot of thought as to interference to

either us or it. The spotty nature of certification was brought home to

me during my Dayton trip. It's no secret to anyone who knows me that I

have a soft spot for the recent influx of inexpensive Chinese radios.

They become eminently col-

lectible as they are cheap and make

interesting toys. They also have an appeal for those of us who wear

dual hats in EMA/ESDAs and such, as it finally lets us go out the door

carrying one radio due to the Part 90 authorization on most of these

devices. I had bought another HT from a dealer at Dayton, different

than the rest of my HTs due to some claimed water resistance. The FCC

logo and cert number were on the box and the radio. At Dayton, not only

did the League have a large presence with their printed matter and

opportunities to meet and speak with HQ folks, but they also had

another interesting activity.
They had a couple of spectrum analyzers

set up and competent folks to run them, with the offer to test any HT

brought forward for spectral purity against the FCC standard. They

offered a nice form with the numbers and a pass/fail grade. So, off I

went with my new toy...and was seriously disappointed. It did not pass

on one band. I know that these radios are cheap and attractive, and at

least one of each flavor was able to pass the spectral purity testing

to obtain acceptance. But, I bet that it would cost *that* much to make

them all pass that standard, just for giggles. I would hate to see all

of these TCBs lose any more semblance of supervision, lest the entire process become worthless. -----

**While we're on the FCC's proceedings, they also issued a citation to

an online retailer who peddles the RM Italy amplifiers. These are all

over Amazon.com like a rash, in several flavors from DC to daylight.

They also apparently are not certified and some operate wonderfully

with CB equipment. We'll see if this stuff disappears from the website.



Okaw Valley ARC Has 220 Repeater!



Kudos to the Okaw Valley ARC in Greenville, IL. They now have an operational repeater on the 220 band (1 1/4 meters)! It is on 224.400 MHz, minus 1.6 MHz offset, with a CTCSS tone (pl) of 103.5 and it is linked to the Greenville 147.165 repeater which is in turn linked back to the 444.250 MHz system.

A big thank you to the trustee s and repeater maintenance committee of the Okaw Valley ARC for putting on the air and maintaining such a fine repeater system!



Antenna Analyzers Don't Tell The Whole Story!

Since late spring, club member Paul, KC9YCP has been experiencing difficulty getting a good signal into the WS9V repeater. Paul has a great signal on two meters, but for some reason 70cm seemed to be eluding him. He never put a "full-quieting" signal into the repeater, but it used to be acceptable.

Paul built a 2 meter J-pole antenna and side mounted it about 20 feet off a TV tower leg. He feeds it with LMR-400 coax.

What had changed?

When an antenna analyzer was put on the antenna his SWR for 2 meters was 1:1.4 across the entire band. On 70 cm it was higher, but at 444.250 MHz the SWR was 1:1.7. Not ideal, but it is acceptable. As it turns out Paul was able to get into the repeater. Four months later, he can barely get into the machine. The analyzer showed the same SWR measurements. What it didn't show was the antenna's radiation pattern.

Let's look at figures I and 2 for they tell the story. To be sure

that is indeed what is happening a quick jaunt in the mobile and comparing field strength measurements east and west and north and south from KC9YCP's antenna indicated little variation on 2 meters and huge variations on 70 cm.

So why did the J-pole seem to work better in the spring and not a few months later? Great question! The answer can be found in the foliage. Leaves are a great RF absorber at UHF and higher frequencies. There is a large tree near KC9YCP's antenna!




J-pole antenna for 2 meters

This is an example of the radiation pattern of an omnidirectional antenna.

Notice that the signal indicated by the red line forms an almost perfect circle.

Paul, KC9YCP's J-pole exhibits this pattern on 2 meters.





This is an example of how an antenna radiation pattern changes from an omnidirectional pattern to one with steep nulls and lobes when it is operated at the antenna's third harmonic.

Although this isn't the actual measured pattern of KC9YCP's J-pole being operated at its third harmonic (70 cm) it gives a good, general idea of what is happening. Relative to Paul's antenna, the WS9V/R is in one of the nulls.

The nulls don't mean that a signal isn't there; rather, it means the signal is greatly reduced as compared to the lobes.

The Greenville, IL club is very active in getting young hams licensed.



For over 50 years the "Peoria SU-PERFEST" sponsored by the Peoria-Area Amateur Radio Club, the Annual "SUPERFEST" has provided the perfect venue in the form of two large buildings where commercial vendors starting at 8:00AM Saturday through 2:00PM on Sunday will offer new and used amateur radios and accessories, computer equipment, peripherals, software and electronic components and a large outdoor open-air Flea Market which begins at 6 AM Saturday, September 21, and runs through 2 PM Sunday, September 22. The flea market will host private sellers with a wide assortment of almost anything electronic.

This year, the Peoria Superfest will host Riley Hollingsworth, retired FCC counsel. In 1998 Hollingsworth became Special Counsel with the new Enforcement Bureau and managed the Amateur Radio Service enforcement and the Land Mobile Service interference resolution programs in the Land Mobile and Public Safety services. Riley is a very entertaining speaker with many stories relating to the enforcement activity and amateur radio in general.
