Here is an e-mail that was forwarded to the bulletin by Bob, W2WG. It is from Greg, SP3V, asking for some support, help and solidarity, from world hams for the Polish hams.

AN APPEAL FOR SOLIDARITY

I am writing to you in the name of PZK
Headquarters with an appeal for
co-operation in addressing the Polish
Ministry of the Environment which is
carrying out a `process of consultations
before issuing a planned Ministerial Decree
on "Installations requiring licensing" and on
"Requirements on licensing of installations
emitting electromagnetic fields".

Let me state in a nutshell: both these Ministerial decrees, if issued as Polish executive regulation, will limit the operation of Polish amateur radio stations operating in the Amateur Radio and Amateur Satellite Services almost to nonexistence. The planned decrees treat amateur radio stations on the same level as commercial radio stations (broadcasting and television transmitters, radio communication transmitters) requiring measurements of electromagnetic field intensities in various directions of the field radiated by the antenna, registration of technical properties of equipment etc. etc.

I would add that, completely unexpectedly, the Polish Ministry of the Environment - who protects the environment from "pollution and electromagnetic fields", did not ask PZK, representing several thousand "emitters of e.m. energy", about our opinion on this subject.

In view of the possible implications of these envisioned governmental regulations, horror and fright inspired our members to organize a protest action consisting of sending thousands (hopefully) e-mails, letters and facsimile messages to the Minister and personally contacting our MPs, with the aim of making "them" understand the nature of our hobby, the practical and technical difference in operation between amateur and commercial emitters etc.

This action of protest is currently taking place in Poland. We, PZK, think that perhaps help from abroad, from our companion amateur radio Societies, the IARU and individual hams, could reinforce and intensify our action. We would be very grateful for your letters sent to the Polish

Minister of the Environment, expressing solidarity with Polish hams and, perhaps, explaining the nature of our hobby, which is not only a "private" hobby and leisure activity, but a social service of great importance. We are confident that such international support will make some impression upon the decision makers in our country, no doubt.

That is why we start this request for help with the title "Appeal for Solidarity"...

One never knows if and when some unknowing government employee in another country might come to a similar idea.

In our case, Polish hams would be compelled to use exclusively EIRP levels of 15 Watts, if the expense of providing measurement proofs to the Government would be too high for individual amateurs. The requirement of registering (licensing) technical apparatus, including antennas, limits any attempts at experimentation, the essential feature of our "hobby".

If you feel you might help PZK by sending a letter, fax or e-mail to the Polish Ministry of the Environment, please do it!


