Jack graduated from high school in 1942 and entered active duty in the Army in Sep 1942 and was assigned to the signal corps as a radio technician and operator. While interested in radio at an early age, Jack passed his Class B (General) test. He was not awarded call letters at that time because the FCC was not giving any out. During this time he took part in the communications preparation for what he later found out to be the liberation of the Philippines. He took part in the invasion and so many men were lost he was called to duty in the operations center. He remembers that Joe Mazur, W8VKW who worked for the press service and could copy 60 wpm (messages were in 5 letter code groups) and was actually used to give information to General McArthur.



One thing that has me mystified is the constant rhetoric about Amateur Radio not attracting enough new people. I read that the ranks are decreasing, hamfest attendance is down and ham radio stores are losing money. I don't know about stores but the other numbers do not add up.

When I got my license, there were about 100,000 hams and a large hamfest was almost a thousand in attendance. The small ones had 50 to 100 with a picnic and no prizes. It was just a

really dying?

I don't think so.

small flea market with hams meeting for an eveball and selling their used gear out of the car trunk. I have some pictures of an an-

nual picnic at Raleigh's Pullen Park circa 1956 and the whole crowd posed for pictures. There were almost 50 people there including families. There must have been at least 35 hams at the park with some traveling more than 100 miles. I remember going to several of those "hamfests" in Raleigh, Rocky Mount, Morehead City and several other places. The only hamfest I can remember in the early 1950's that offered prizes was at the Charlotte National Guard Armory. I think there were several hundred in attendance but it could have topped one thousand. I went to a Shelby hamfest in 1954 and there were less than a hundred in attendance. We were in a parking lot next to US Highway 74 around the cars. That was 46 years ago. The Shelby hamfest everyone goes to now will be what is called the 44th annual hamfest. Last year's attendance was more than 15,000 and that's an increase of more than 1500 percent for a now have several hundred or more in attendance and prizes are always offered.

As far as the number of licensed Amateur Radio operators, in the early 50's, there were about 100,000 licensed. Now there are more than 700,000, an increase of more than 700 percent. The population of the United States has increased about 100 percent during that time. It sure looks like the Amateur Radio population has increased more than seven times faster. And some say Amateur Radio is dving.

With the new license regulations, time will have to tell if it helps with a sharp jump in licenced hams. The biggest effect will be the large number of upgrades from presently licensed hams. The ARRL Executive Vice President states that there were the least failures in Novice and Extra exams. For one, the

> Novice is supposed to be the easiest exam and the ones that take the Extras have done it because they pected to pass the

20 WPM code test and put a lot of study in it. Everyone says that the present Advanced exam is harder than the Extra. If that is true, it looks as though that the proper questions have not been written for the Extra or maybe the Advanced. With the new regulations, one has to only take a total of 130 questions for the Extra license. The present route for the Extra is 185 questions. Also, the word is out that the questions for the new exams are about the same with Advanced and Extra being combined. So the persons starting out in Amateur Radio will have a CW exam that is 75 percent slower and they will have 30 percent less questions to get to the Amateur Extra!

I can understand the excitement of others that have a chance to upgrade. If I had a lower class license or was just starting in Amateur radio, I would be very happy for the opportunity. I am also happy that some of my relatives will soon

FCC Threatens Michigan Ham With **Revocation Hearing**

The FCC has told a Michigan ham he could face a revocation hearing if the Commission gets any more reports alleging malicious interference. A Warning Notice went out February 23 to Tech Plus licensee Allen J. Stap Sr, N8OKU, of Bangor, Michigan. In it, FCC Special Counsel for Amateur Radio Enforcement advised Stap that the FCC has received "numerous complaints regarding malicious interference and jamming, apparently originating from your station" to a Hollingsworth said 2-meter repeater. some of the interference to the Kalamazoo Amateur Radio Club's repeater consisted of "sound effects, unidentified transmissions and keying over ongoing communications." The FCC said there was further evidence that the licensee had been harassing repeater users.

Hollingsworth warned Stap that if "legitimate complaints or our monitoring reveal additional instances of this behavior," the FCC intends to designate his station license for a revocation hearing and his operator license for suspension for the remainder of its term.

guilty in a Michigan district court to interfering with the transmission of public safety messages. He was sentenced to nine months probation and ordered to surrender his 2-meter gear for the duration.

Elsewhere, the FCC has requested that Jeffrey G. Guss, KF4MWT, of Palm Bay, Florida, retake the Technician class amateur examination elements by March 30 or lose his license. In 1997, Guss was cited for unlicensed operation on 154.6 MHz, for failing to permit FCC personnel to inspect his radio equipment, and for failing to reply to FCC correspondence. Early last year, the FCC upheld a \$2500 fine levied against Guss and denied a payment extension. It's not known if Guss ever paid the forfeiture.

In Salisbury, North Carolina, the FCC wrote Advanced licensees James W. Walls, NC4JW, and Jerry W. Cartner, K4JWC, and Tech Plus licensee James R. Christie, KF4QWR, on February 24, citing information that the licensees have been using ham gear on the Citizens Band and other frequencies. The FCC also alleged they had been selling transmitting equipment that does not meet FCC certification standards over the air on those frequencies and operating above authorized CB power limits. In separate letters, Hollingsworth warned all three that such operation could jeopardize their amateur licenses. The FCC gave the three licensees 20 days to respond to the allegations. - via ARRL Letter Online 3/3/00

FCC Gives Morse Element Credit to Expired Novices

Anyone who ever held a Novice ticket--expired or otherwise--will be able to claim credit for Element 1, the 5 WPM Morse code examination, under revised Amateur Radio licensing rules going into effect April 15. The change was included in the version of the FCC's restructuring rules, published February 10 in The Federal Register.

The change affects §97.505(a) (5) of the rules that spells out element credit. That sentence now says: "An expired or unexpired FCC-granted Novice Class operator license grant: Element 1."

The rules already give Element 1 credit for those holding an expired or unexpired FCC-issued Technician Class operator license document granted before February 14, 1991, as well as to applicants possessing an FCC-issued commercial radiotelegraph operator license or permit that's valid or expired less than 5 years.

There's no indication, however, that the FCC intends to extend Element 1 credit to applicants who once held any other FCC-issued licenses now expired, including Tech Plus, General, Advanced, or Amateur Extra.

Because of other anomalies in the new rules, the ARRL is recommending for now that holders of Novice or Tech Plus licenses retain their license documents or copies in the event they need to claim Element 1 credit when upgrading under the new rules. When renewed after April 15, 2000, Technician Plus licenses will come back stamped "Technician," and the FCC has said it does not plan to keep track of which Technicians have Morse code element credit and which do not.

The FCC also has indicated to the ARRL that post-April 15 Technicians who subsequently qualify for HF operation by passing Element 1 will retain element credit for upgrading purposes only for 365 days--the term of a Certificate of Successful Completion of Examination-not permanently, although this will not affect their ongoing Novice/Technician HF privileges. FCC Fines Two Texas Amateurs for Malicious Interference

The FCC has fined two Texas hams \$8000 apiece for allegedly interfering with a local repeater and failing to identify. Paul E. Holcombe, K4TOF, and Robert L. Myers, N5WLY, both of Houston, were notified last month by the FCC's Houston office. The fines come in the aftermath of an FCC investigation undertaken last year that involved the use of direction-finding equipment. The FCC says it's been hearing complaints of interference to the Memorial Emergency Repeater Association's system for more than five years now.

On separate occasions in February and May, FCC personnel from the Houston field office used direction-finding gear to track transmissions interfering with MERA's 145.47 repeater to Holcombe's and Meyers' vehicles. As a result, Holcombe and Meyers each received a Notice of Violation from the FCC last June. Since being cited, both men have denied the allegations in statements to the FCC.

In both cases, the FCC determined otherwise and ordered Holcombe and Meyers to pay the fines within 30 days or to file written statements showing why the forfeitures should be reduced or canceled. - via ARRL Letter Online



rules, affected Technicians attempting to upgrade more than a year after passing Element 1 would have to retake the Morse code examination.

The ARRL plans to file a petition for partial reconsideration asking the FCC to continue to keep track of which Technicians have Morse code element credit and which do not. The League also will ask the FCC to make Element 1 credit permanent for post-April 15 Technicians who successfully pass the Morse exam.

FCC Continues W5YI-VEC South Carolina Exam Audit

As part of a continuing audit of several W5YI-VEC examination sessions last summer and fall in South Carolina, the FCC is seeking details from two volunteer examiners concerning a test session in Iva, South Carolina. The FCC already is looking into W5YI-VEC exam sessions in Clemson last summer.

In separate letters January 28, FCC Special Counsel for Amateur Radio Enforcement Riley Hollingsworth wrote volunteer examiners Eugene D. Watring,

quested that Watring and Chambers provide detailed information concerning the October 9, 1999, exam session in Iva at which both were listed as an assisting VE under William J. Browning, formerly AB4BB and AF4PJ, a central figure in the probe. Browning's Amateur Extra license was canceled after he failed to appear for retesting.

Copies of testing-related documents that Browning had submitted following the examination session accompanied the FCC inquiry. Hollingsworth asked Watring and Chambers if either

Watring and Chambers were requested to provide the information within 30 days.

has requested that Chambers retake his Amateur Extra class examination. Several individuals who took and at the targeted South

passed examinations at the targeted South Carolina sessions last summer and fall were designated for retesting. The FCC already has canceled the licenses of two individuals tested at the October 9 session after the individuals failed to show up for retesting.

Chambers, Watring and Browning were said to have served as VEs for other W5YI-VEC testing sessions last summer, and the FCC also is looking into allegations of irregularities at those sessions. The W5YI-VEC is cooperating in the probe. - *via ARRL Letter Online*

ARRL-VEC to charge for code tests

Starting with the inception of the new FCC Amateur Radio licensing rules on April 15, 2000, the ARRL-VEC will charge a test fee of \$6.65 to take the Element 1 (5 WPM Morse code) test. 

Michigan Ham Yields License Until 2004 in Exam Case

The FCC has cut a deal with former ARRL-VEC Volunteer Examiner Andrew Penn, N8JVA, whose license was designated for a revocation hearing in the wake of 1997 examination irregu-

larities in Michigan. A February 7 letter to Penn from FCC Special Counsel for Amateur Radio Enforcement Riley Hollingsworth affirms the terms of a voluntary agreement calling for Penn to turn in his Amateur Extra class license for three years, ten months in lieu of

The FCC action stemmed from a June 3, 1997, Oak Park, Michigan, examination session for which Penn was a

VE and submitted the paperwork for applicants, one of them Penn's son. As a result of an FCC investigation, the FCC downgraded the license class of two applicants and canceled the license of

Penn's son, Steven A. Penn, formerly KC8HUM. FCC evidence indicated that Andrew Penn added to the exam session package paperwork for applicants who did not pass the required examination elements at the Oak Park session. Evidence also indicated that Andrew Penn

apparently applied to the application papers the signatures of three other VEs without their knowledge.

The FCC says that three of the

examiners knew nothing of the scheme. The other three Ves brought the situation to the attention of the ARRL-VEC and the FCC.

The FCC agreement calls for Andrew Penn to turn in his license by April 20, 2000. He will be allowed to request renewal of his license on February 21, 2004, the day before his current license term ends. - via ARRL Letter Online 2/11/00

ARISS Crews get Initial Ham Gear Training

The first International Space Station expedition crew and its backup crew have received some initial training on the use of the initial US-provided Amateur Radio gear to be installed as part of the Amateur Radio on the International Space Station, or ARISS, effort. The session was conducted at Russia's Gagarin Cosmonauts Training Centre.

As part of the ARISS training effort, NASA's Matt Bordelon, KC5BTL, is preparing a consolidated schedule for training in the US and in Russia that will include familiarization with equipment, packet theory and hands-on training, using a hardware mockup, and simulation. Training will focus on general principles of ham radio as well as preparations to use ham radio, equipment types and operating modes, and general packet module information and software.

Bordelon has held an initial training session with astronauts and cosmonauts that provided exposure to the actual hardware. Other training has included the information required to obtain an US Amateur Radio license. The first ISS crew includes US astronaut Bill Shepherd, KD5GSL, and Russian Cosmonauts Sergei Krikalev, U5MIR, and the recently licensed Yuri Gaidzenko, whose call sign was not available.-Carolynn Conley, NASA - via ARRL Letter Online 2/25/00

Enhanced DXCC Card Checking Coming

The ARRL DXCC Desk says that effective April 1, 2000, DXCC members may have their cards checked by local card checkers without having to mail cards to ARRL Headquarters. Under the new program, DXCC card checkers will be able to check all awards except 160 meter DXCC, as well as all QSLs from any current DXCC entity. This will apply to both new awards and endorsements. QSOs made up to 10 years prior to the current year will be eligible for field checking, while older cards and those from deleted entities still may be sent to ARRL HQ. The current DXCC Field Checking program ends March 31, 2000. Reappointment of DXCC Card Checkers under new criteria will be necessary. Canada, Australia eye Morse Speed Reduction

Canada and Australia could follow the US in reducing the Morse code examination requirement to 5 WPM for full HF access. Radio Amateurs of Canada announced plans this month to ask Industry Canada to eliminate that country's 12 WPM Morse requirement. The RAC Board of Directors has voted unanimously in favor of the proposal, expected to be filed soon. If enacted, the change would leave 5 WPM as the sole Morse code examination requirement for full HF access in Canada.

Meanwhile, the Wireless Institute of Australia reports it's seriously considering whether to push regulatory authorities to reduce the maximum Morse code license test speed Down Under from 10 to 5 WPM. WIA says it expects to discuss the matter in detail next month with the Australian Communications Authority.

The WIA says a majority of its membership divisions appear to favor the reduction from 10 to 5 WPM in Australia. The general issue of Morse code licensing requirements is expected to be a topic for debate at the IARU Region 3 conference the WIA will host later this year. Discussion of the International Radio Regulations regarding the Morse code requirement is not expected to come up prior to the World Radiocommunication Conference set for 2003.

A single 5 WPM Morse code examination requirement for HF access goes into effect in the US on April 15 as part of sweeping licensing rules changes. The United Kingdom and Sweden also have adopted 5 WPM as the Morse code examination requirement for access to the full HF amateur spectrum. The South African Telecommunications Regulatory Authority is said to be poised to act on a South African Radio League request for a lower code speed limit there. Other nations have expressed interest in the issue.

The Israeli Ministry of Communications has introduced a new license with a 6 WPM Morse code requirement that gives CW-only access to HF bands. The new ticket does not include all HF bands, however. - via ARRL Letter Online 2/18/00

After the war, Jack got his W3MCB call sign. utilizing the GI Bill, he went to school and became a radio engineer. His first job was with a commercial broadcast station WCAE in Pittsburgh -twice he work with Edward R. Morrow. Jack later worked for other stations and in 1961 he joined the Radio Voice of Gospel of the Lutheran Church and was assigned to Ethiopia and stayed there until 1964. He used the call sign ET3JK and was active on the air He worked 330 countries using a 20 meter quad. In 1962 in a 10 to 12 hour period he and another ham worked 1800 to 2000 QSO's.

Coming back to the US Jack joined the VOA and was assigned to Greenville, NC and remained with them for 25 years. retiring June 1990 and continued living in Greenville for about six more years.

In 1967 Jack Kear, K4MI and four or five other hams including Bob Knapp, Charlie Wells, Lemar Reed, and Ray Avis met and created the Brightleaf Amateur Radio Club. The defunct Greenville Amateur Radio Club donated \$110.00 which was left in their treasury. One of there reason Jack gives for the selection of "Brightleaf" is because the tobacco companies would pay for the QSL cards! He credits Bob for making the major effort during the early years of the club - sometimes BARC stood for *Bob's* Amateur Radio Club.

Jack's current equipment include: TenTec Omni Six Plus; using a Icom 738 as back up and Has a Kenwood TS 830 on the shelf. He lives on .8 acre on a hill which he is able to use to his advantage. He has a Gap Titan DX up 28 feet. He also enjoys building antenna and has a 20 meter 1/2 square at 40 feet; a 15 meter 1/2 square at 60 feet and a 160 meter inverted L. He utilizes the trees that are available and prefers a Double Wang sling shot to snag the limbs. He is working on an 80 meter super loop phased antenna configuration. He also likes the Gem Quad. On 2 meters he has a 5/8 vertical up about 30 feet. Jack has published an article in Jan 1972 QST on the Shortened Z L Special entitled "Five DB for \$5.00". That March, he had comments in QST in the Tech Topics section.

His interests include antennas, DX and has many scheds during the week including one with Greenville ham Henry Peszco, WB4DWC and others in the VOA and in the broadcasting field.

While not quite sure after all these years, Jack thinks he was president of BARC at one time and taught some new ham classes.

Many of our members will remember Jack's wife Zelda who died Jul 12, 1997. He has two children Robert who lives in Harrisburg, NC and Regina living in Factoryville, PA. He has one grandchild, Johnathan.

Ham radio has provided, and continues to provide, a beneficial and challenging activity. Jack is one of the founding fathers of BARC and we owe him and the others a great deal of thanks in making the effort that we benefit from now. Thanks Jack. - *K4MHM*

FCC Affirms Fine; Unlicensed Operation Continues

The FCC has affirmed a \$20,000 fine levied on a Florida man last summer for unlicensed operation, willful and malicious interference with Amateur Radio communications, and failure to let the FCC inspect his radio equipment. The FCC's January 28 Forfeiture Order gives William Flippo of Jupiter 30 days to pay up or the matter will be referred to the US Attorney.

Following an FCC Warning Notice, Flippo initially was notified of the fine last July in an FCC Notice of Apparent Liability. Hams in Florida say Flippo has thumbed his nose at the FCC and has continued to flout the law by interfering with local HF and repeater nets. FCC personnel from the FCC's Tampa District Office have followed up on complaints from amateurs that Flippo--also known by his CB handle of "Rabbit Ears"--has regularly interfered with hams on 10 meters, 2 meters and elsewhere. The Order acknowledges that the Commission has received information on "at least five occasions" since the fine was levied last July indicating that Flippo continues to violate federal law.

Flippo's only response to last year's Notice of Apparent Liability was to send the FCC a copy of a one-page bankruptcy filing. The FCC was not impressed, however. "In a case where an NAL has been issued and the recipient continues to engage in the same conduct, we are not inclined to adjust the forfeiture amount, even where the recipient has filed for bankruptcy protection," the Commission said.

One Jupiter-area ham who has cooperated with the FCC investigation says Flippo has been causing problems for the amateur community in his area since late 1997. He and fellow members of the Jupiter-Tequesta Repeater Group want to see the FCC take a stronger stand in the case.

"I want to see the guy in jail-plain and simple--and his equipment confiscated," said the amateur, who did not want to be identified by name fearing retaliation. "The problem is, we're all playing by the rules here, and this guy goes out and buys a radio and he gets on there **HF** and does whatever he wants and brags about it."

FCC personnel from the Tampa NTS CW Nets office have visited the Jupiter area at least twice last year as a result of amateur complaints alleging malicious interference from Flippo, primarily on VHF but also on some HF amateur bands. - via ARRL Letter Online 2/18/00
