# Ducie Island DXpedition launch in final countdown

The Daily DX reports that plans for the Ducie Island DXpedition of 2002 are now complete, and the group is in the final countdown phase. Approved last fall as a DXCC entity, Ducie has not yet been activated--which places it at the top of everyone's most-wanted list. The team expects to leave French Polynesia March 12. The first stop will be at Pitcairn Island to pick up supplies and equipment left from the first Ducie attempt last fall. The team then will proceed to Ducie Island for a one-week operation. Current plans call for round-the-clock CW and SSB operation on 15 meters (21.020 and 21.295 MHz). There will be some operation on all bands, 160 through 6 meters, CW, SSB and RTTY. 

The Brightleaf Amateur Radio Club has had a web site since 1996 starting off at GeoCities.com. The server was offered free to individuals, nonprofit clubs, etc. The site worked out very well for a while until they started inserting popup ads. In July 1999, the main BARC site was moved to OSL.NET, a server with just Amateur Radio interests. It is supported by many small contributions from users. I have tried to maintain the GeoCities site with notifications and jumps to the QSL.NET site. This was because many other sites have links to the old URL address. I have notified the sites I find it on, but most of the time, they don't update their own site!

A couple of years ago, Yahoo bought out GeoCities and they added more popup ads and also changed URL's on most of their sites. Now they are putting more restrictions on uploading for the free sites. These restrictions and popup ads will be removed for \$4.95 per month. I am going to put up a simple page on the Yahoo/GeoCities site to automatically link and shift to the QSL.NET page. They might decide to drop the GeoCities site if it is not used enough. I think three years is enough time for everyone to change over to QSL.NET so it will not be a big loss. RACES and they conducted weekly emergency practice. Speaking of scouts, he achieved eagle scout and silver award of the explorers.

He speaks with pride of his early radio days of experimentation and building. Of particular interest is an AM transmitter he built using an 813 with a 6L6 driver. Born during the early years of TV it managed to wipe out anything within a block and to his janitor's dismay, made switched off light bulbs glow red in the midst of RF radiation. He became infamous, "Everybody knew my name."

He started a electrical engineering degree at City College in New York and finished up a 2 year degree at RCA (school) in electronics engineering specializing in broadcasting. His equipment now consists of: Icom 746 transceiver, a Hy-Gain TH7 antenna, 22 element Mirage 2 meter vertical/horizontal antenna for SSB and FM, Icom W31A a 2 meter/440 hand held. Rick notes a considerimprovement since Riley Hollingsworth, K4ZDH, whom he has spoken to, has come on the scene.

# Wayne C. Williams, K4MOB, SK

Wayne Williams, K4MOB, of Colfax, North Carolina, died February 12 after an extended illness. He was 65. An ARRL member, Williams served from 1977 to 2000 as editor of the Southeastern Repeater Association's SERA Repeater Journal. As the proprietor of Williams Radio, Williams was a familiar and welcome presence on the hamfest and convention circuit in the southeastern US. Current Repeater Journal Editor Gary Pearce, KN4AQ, hailed Williams as a "driving force in SERA," the frequencycoordination body for eight southeastern states. During his tenure as editor, Williams transformed the Repeater Journal from a newsletter to its current color-cover magazine format. "Wayne touched the lives of thousands of hams in the Southeast," Pearce said. "We'll miss him." Williams' survivors include his wife, Gerry, KB4SEL, and two sons, Chris, W4CAW, and Wayne Jr (a third son, Gary, died in 2000). The funeral was February 14. - via ARRL Letter Online 2/15/02

### Lone missing application holding up vanity system

And then there was one. The FCC indicated this week that a lone missing paper vanity call sign application filed last October is holding up the resumption of routine vanity processing. On February 27, the FCC processed 33 vanity applications received last October 23 and 24. The following day, it ran another 41 applications received October 25 and 26. Processing remains stalled beyond that receipt date, however. FCC efforts, assisted by the ARRL, to contact the elusive applicant to have the individual resubmit a vanity application have proven more difficult than ever anticipated.

The FCC appears determined to hold off further processing until the

remaining applicant is given an opportunity to resubmit an application and, thus, retain a place in the processing queue. Prior to this week, no amateur vanity call signs had been granted since February 1, when applications received at the FCC October 22, 23 and 24 were processed. The FCC later rescinded vanity grants for October 23 and 24, however, after it realized that it needed further information for an October 23 application. Until late January, no vanity call signs had been issued since October 30.

The ARRL estimates that some 2050 vanity applications now are in the FCC's processing pipeline--the majority of them filed electronically. The FCC's

policy is to give equal processing weight to paper and electronic applications. Some two weeks' worth of October paper vanity applications apparently were mislaid after mail was sent off last fall for anthrax decontamination.

F C C W i r e l e s s Telecommunications Bureau personnel at the FCC's Gettysburg, Pennsylvania, office used information gleaned from payment receipts to contact the known paper filers via e-mail or telephone to have them resubmit copies of their vanity applications. That effort-again with ARRL help--led to this week's vanity processing. - via ARRL Letter Online 3/1/02

### FCC redesigns Amateur Service web site

The FCC has redesigned its Amateur Radio Service Web site and changed the URL <a href="http://wireless.fcc.gov/services/amateur/">http://wireless.fcc.gov/services/amateur/</a>. The new layout makes it easier to find information on topics most requested by amateurs, including licensing, amateur exams, filing an application, changing an address or using the Universal Licensing System (ULS). The refurbished site also provides links to recent Amateur Radio-related news from the FCC.

"The new design is a part of the Wireless Telecommunications Bureau's continuing effort to meet the needs of the Amateur Radio Service operators as identified in focus groups, letters, phone calls, and e-mails," the FCC said in a news release.

The new design clusters FCC public notices, news releases, and other official documents affecting Amateur Radio operators on the right side of the page. On the left side of the page, the new navigation scheme displays information on the Amateur Radio Service, the sequential call sign system, licensing and vanity call signs as well as amateurrelated communications policies such as reciprocal agreements. The site also offers links to information on the limited federal preemption known as PRB-1, the Part 97 Amateur Service rules and the Wireless Telecommunications Bureau and ULS sites.

The site, launched on February 20, includes a search engine for the entire FCC Web site <a href="http://www.fcc.gov">http://www.fcc.gov</a>. Published as part of the QST Public Service column, the PSHR recognizes amateurs who demonstrate exemplary public service performance each month. In addition to streamlining the criteria, updated PSHR categories will combine some now-separate areas of qualifying performance into a single category. The new regime also will readjust point credits and, in some cases, point limits for individual categories.

Among the most significant changes is a revised schedule to earn points for participating in planned or unplanned public service activities. Current criteria provide 10 points for each event, with no limit, for "participating in a communications network for a public service event." Under the new criteria, stations can earn unlimited PSHR points at the rate of five per hour of participation in scheduled, short-term public service events. Participants now also may credit certain time spent planning and coordinating activities toward their total. Stations can earn unlimited points at the same rate for participating on the scene during an unplanned emergency response

or as part of an unplanned incident request for Amateur Radio participation by a public or served agency.

The ARRL Board of Directors adopted the program changes--proposed by the ARRL Volunteer Resources Committee--at its January meeting. The revisions, the first in 11 years, resulted from comments expressed by the Amateur Radio public service community during a 2001 survey.

"An ongoing challenge with PSHR is how to effectively balance the many different facets of Amateur Radio public service communication," said ARRL Field Organization/Public Service Team Manager Steve Ewald, WV1X. Ewald conceded that the assignment of point values was "a delicate task." He said the criteria attempt to present a balanced program without being too complicated. The new criteria will recognize performance in six categories--down from eight. The minimum point total will remain at 70. Under the revised program:

- \* Participating in a public service net will earn 1 point per net session, up to a maximum of 40 points.
- \* Handling formal messages will earn 1 point per message handled, up to a maximum of 40 points.

- \* Serving in an ARRL-sponsored volunteer position is worth 10 points for each position, up to a maximum of 30.
- \* Participating in scheduled, short-term public service events, including off-the-air meetings and coordination efforts with related emergency groups and served agencies, earns 5 points per hour, with no points limit.
- \* Participating on the scene in an unplanned emergency response or on or off the scene as part of an unplanned incident request for Amateur Radio participation by public or served agencies earns 5 points per hour, with no points limit
- \* Providing and maintaining either an automated digital system, such as a packet bulletin board, to handle ARRL radiogram-formatted messages, or a Web page e-mail listserver oriented toward Amateur Radio public service is worth 10 points per item.

### Amateur antenna bills filed in Tennessee

Tennessee has become the latest state to consider Amateur Radio antenna legislation. Identical bills were filed January 31 in both houses of the 102nd Tennessee General Assembly that would incorporate the essence of the limited federal preemption known as PRB-1 into state law.

House Bill 2973 and Senate Bill 3058 would amend Tennessee law to require that municipalities regulating the placement, screening or height of radio antennas "reasonably accommodate amateur radio antennas" and impose only the "minimum requirements necessary" to meet legitimate local requirements. In addition, if the legislation is approved and signed by Gov Don Sundquist, municipalities in Tennessee would not be able to restrict the number of support

structures for an Amateur Radio antenna.

The proposals would limit municipalities from imposing restrictions on Amateur Radio antenna height according to a three-tier schedule. In rural areas



with a population densities of 120 or fewer per square mile, the minimum regulatory height would

be 200 feet; in areas where the population density exceeds 120 per square mile, the minimum regulatory height would be 140 feet on lots of an acre or larger and 75 feet on lots of less than one acre.

Municipalities still would be able to impose requirements "to meet

clearly defined objectives relating to screening, placement, aesthetic, and health and safety factors with respect to the erection, maintenance and operation of amateur radio antennas." The proposed bills would grandfather amateur antennas already in place before the effective date of the legislation.

Both bills now are in committee. The full text of the proposed bills is available on the Tennessee General Assembly Web site <a href="http://www.legislature.state.tn">http://www.legislature.state.tn</a>. us/bills/currentga/BILL/HB2973.pdf>.

Thirteen states have incorporated the essence of PRB-1 into their laws. A measure awaits the governor's signature in Wisconsin. New PRB-1 legislation or bills to expand existing PRB-1 laws are under consideration in at least three other states. - via ARRL Letter Online 2/22/02
