ARRL VEC examination fee to rise

Starting January 1, 2003, the fee charged all applicants at ARRL VEC-coordinated Amateur Radio test sessions will increase from \$10 to \$12 for the year 2003. This fee is charged to anyone applying for a new amateur license or upgrading their operating privileges.

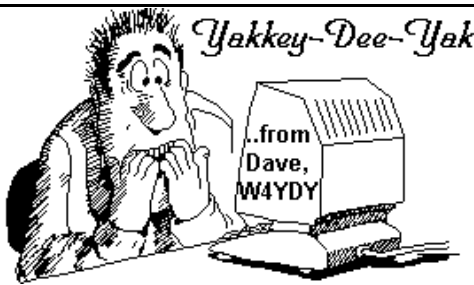
"While the number of examinees has remained relatively unchanged in the past 24 months, our cost of doing business-and the expenses incurred by ARRL VEC-continues to rise," said ARRL VEC Manager Bart Jahnke, W9JJ. "An adjustment was needed in the 2003 test fee if we intended to maintain the same level of service that our VEs and VE teams have come to expect."

Applicants failing an exam element at ARRL sessions where examiners permit retesting on the same exam element also must submit a retest fee of \$12. Additionally, the maximum reimbursement ARRL VEC allows ARRL volunteer examiner (VE) teams to retain to directly offset their "prudently incurred" out-of-pocket expenses will go up from \$4 to \$6 in 2003 (this fee has remained at \$4 per person served since 1991).

Jahnke said that adjusting the reimbursement level for ARRL VEs also was past due. For more information, contact ARRL VEC, vec@arrl.org. - *via ARRL Letter Online 11/15/02*

Annual Skywarn recognition day is December 7

The fourth annual SKYWARN Recognition Day (SRD) <<http://hamradio.noaa.gov/>> is December 7 (UTC). That's when Amateur Radio operators set up stations at National Weather Service (NWS) offices and contact other operators around the world. The event is sponsored by the ARRL and the National Weather Service.

"The purpose of the event is to recognize the vital public service contribution that Amateur Radio operators make during National Weather Service severe weather warning operations," said David Floyd, N5DBZ, warning coordination meteorologist, at the NWS Goodland, Kansas, office. "It also strengthens the bond between Amateur

Radio operators and the local National Weather Service office."

For several decades now, hams have assisted the NWS by providing real-time reports of severe weather and storm evolution. The information radio operators locate near a storm can provide plays a key role in aiding forecasters. SKYWARN operators in several states activated to spot and track an outbreak of severe thunderstorms and tornadoes November 10.

Scott Mentzer, N0QE--the meteorologist-in-charge of the NWS office in Goodland, Kansas, and the creator and annual organizer of SRD--says more than 90 stations are registered to participate, up from 80 last year. Most participating NWS stations will operate on 80, 40, 20, 15, 10, and 2 meters using SSB and FM. Mentzer says a number of NWS offices will be equipped to support Internet Radio Linking Project (IRLP) stations.

All contacts will be made utilizing the General or Novice portion of the bands. Stations will exchange signal report, location and a one-word description of the current weather at their respective locations ("sunny," "partly cloudy," "windy," etc). This is not a contest, so no scoring will be computed.

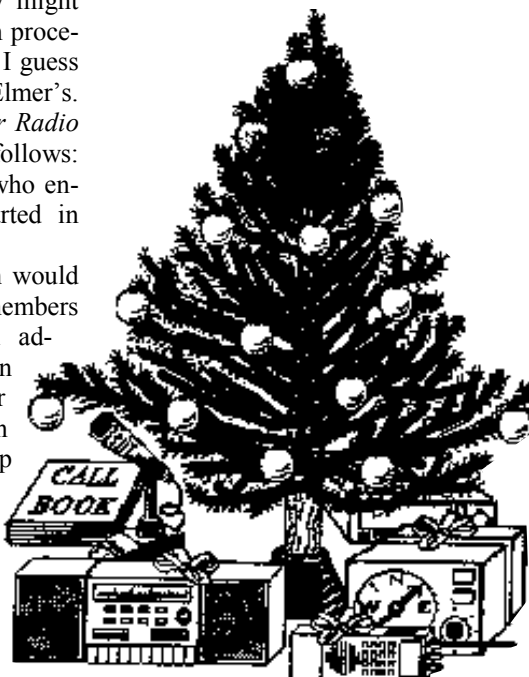
SKYWARN Recognition Day will take place December 7 from 0000 UTC to 2400 UTC. Since SRD is being held on Pearl Harbor Day, each NWS office will transmit a special message from approximately 1800 to 1900 UTC--approximately the time of the Pearl Harbor, Hawaii, attack on December 7, 1941--to honor the World War II veterans.

The list would contain the areas that the Elmer could help with, such as antennas, VHF, HF, transceivers, net operations, etc. The list could be printed in *Ham Chatter* several times a year and also be given to new ham class students. If anyone is interested in chairing the committee, please let BARC President Dave LeMoine, KV4CN, know. Does anyone have a suggestion for a chairperson????

Ohio Ham suspended following repeater interference

An Ohio amateur accused of interfering with a local repeater system has agreed to stay off the air for one year. FCC Special Counsel for Enforcement Riley Hollingsworth notified Gary R. Weiler, KI8DI, of Loveland by letter October 22 to confirm the voluntary license suspension.

"The interference consisted of sound effects, harassment and unidentified communications," Hollingsworth said in his letter. In late September, Hollingsworth had served Weiler with a Warning Notice citing monitoring information alleging that on several occasions since last March Weiler had "deliberately interfered" with the K8CLA repeater in Cincinnati, Ohio. The Warning Notice also threatened him with enforcement action up to and including a fine of up to \$7500 and revocation of his amateur license.

Hollingsworth credited the Cincinnati Amateur Radio Club with helping to pin down the source of the interference to Weiler's location. In his reply September 30, Hollingsworth said, Weiler owned up to the infractions and said they'd involved a personal dispute of some kind. "He said he realized he shouldn't have done it," Hollingsworth said.

After reviewing his reply, Hollingsworth said Weiler agreed to the proposed one-year suspension, during which he will not maintain an Amateur Radio station. FCC said the suspension will end at midnight October 30, 2003, and that Weiler's amateur license would be returned automatically on or before that date.

On October 24, Hollingsworth issued a welcome reminder to Danny A. Kenwood, WA6CNQ, of San Francisco. In November 2000, Kenwood agreed to a modification of his ham ticket that prohibited all but CW operation below 30 MHz for two years. It was not the first FCC sanction Kenwood had endured. In the fall of 1999, Kenwood lost his VHF and UHF privileges for 90 days following allegations of profanity, obscenity and deliberate interference directed at users of the K7IJ Grizzly Peak repeater, and of

RC-03 Conference preparatory meeting under way

The Conference Preparatory Meeting (CPM) for next year's World Radiocommunication Conference (WRC-03) opened in Geneva, Switzerland November 18. Some 1000 delegates are attending the worldwide gathering.

"The objective of the CPM is to approve a 500-page CPM Report to WRC-03 that will provide a technical basis for consideration of administrations' proposals for changes in the international Radio Regulations," explained ARRL Chief Executive Officer David Sumner, K1ZZ. Sumner is attending in his role as International Amateur Radio Union (IARU) secretary. He says 174 "input documents" to the CPM offer comments on the existing draft CPM Report text and propose additions, deletions, and changes.

Chairing the CPM is Germany's Eberhard George, DL7IH. At the day-long opening plenary, George and the chairpersons of the various working groups provided an overview of the meeting's structure and the major issues facing WRC-03.

"Several of the working group chairs were quite candid in their remarks," Sumner said. "Music to many ears including amateurs' was the assessment by New Zealand's Alan Jamieson regarding so-called little LEOs--mobile satellites operating below 1 GHz." According to Sumner, Jamieson said there was no congestion in their existing bands,

failure to properly identify.

In the spring of 2000, the FCC issued Kenwood a Warning Notice on the basis of reports from the K7IJ repeater system control operator that the repeater had to be shut down due to what Hollingsworth called Kenwood's "interference and harassment to other operators on the repeater system." Kenwood subsequently agreed to the HF CW-only sanction. The modification of Kenwood's General license expires December 1. - *Via ARRL Letter Online 11/8/02*

and sharing studies had been unfavorable. Sumner predicted that the likely outcome at WRC-03 would be the suppression of an existing Resolution that invites sharing studies on the basis of an "urgent need" that no longer exists.

A thornier issue is 7-MHz "harmonization." The IARU backs a 300-kHz worldwide allocation in the vicinity of 7 MHz. "At this stage, we have six methods to address the agenda item," Sumner said--

including no change in the status quo. The item is in Working Group 5 (WG5) "We can't say for sure that the six methods will be in the CPM Report until WG5 takes another pass at the revised draft text and it's approved in plenary." That's not supposed to happen until next week.

Substantive work of the CPM will be wrapped up November 28--Thanksgiving in the US, but just another work day in Geneva.

In addition to Sumner, those representing the IARU at the CPM include President Larry Price, W4RA, and Region 1 Executive Committee member Wojciech Nietyksza, SP5FM. IARU Vice President David Wardlaw, VK3ADW, is on the Australian delegation and ARRL Technical Relations Manager Paul Rinaldo, W4RI, is on the US delegation.

Several other amateurs are on their national delegations, either to represent the amateur services or in professional capacities. - *via ARRL Letter Online 11/22/02*

tracted polio. He was laid up for six months and became a mail clerk. In 1958 he started in the photography business. No comments filed on multiple vanity applications petition

A Petition for Rulemaking put on public notice (RM-10582) by the FCC in late September that asked the Commission to consider only one vanity call sign application per applicant per call sign attracted no comments. The period for comments ended in late October. The application, filed by Marvin Edwards, K4BWC, Frank Lynch, W4FAL and Norman Young Jr, KA4PUV, sought either a change in Part 97 Amateur Radio Service rules or modification of the FCC's current vanity call sign policy. FCC rules do provide for filing comments beyond the filing deadline, but commenters must justify the reason for late filing. The petitioners said that permitting multiple applications from the same applicant for the same call sign "has created a de facto lottery" that favors applicants who can afford to pay multiple application fees (now \$14.50 per application and refundable if the call sign is not granted) and put applicants unable to do so at "a distinct disadvantage." The petitioners also cited specific instances where the winners of particular call signs had filed as many as 30 separate applications. By dismissing all applications after an initial vanity request for a given call sign, the FCC "would permit every licensed amateur competing for an available call to have an equal chance of having that call granted," the petitioners concluded. - *via ARRL Letter Online 11/8/02*

DXCC Legend Bob White, W1CW, SK

Former ARRL Headquarters staff member Bob White, W1CW, died November 22 in Florida from complications arising from pneumonia. He was 83. White was an ARRL Life Member and had belonged to the League for 62 years.

Known to many as "Mr DXCC," White was the manager of the ARRL's DX Century Club program from 1952 until 1976, establishing the award--and its stringent standards--as Amateur Radio's premier DX achievement. White codified the rules for the DXCC program and oversaw the checking of some 250,000 QSL cards submitted yearly, often working as many as 90 hours a week to ensure that the job got done right. White also oversaw the ARRL QSL Service from 1976 until 1978.

"Dad was the guy who made DXCC what it was," said White's son, Jim White, K4OJ, in a posting to the CQ Contest reflector. "He didn't cut any corners--everyone was held to the same high standard--and this is what made holding DXCC meaningful."

Introduced to Amateur Radio in his youth by his stepfather, Gordon Brown, W6APG, White was first licensed in 1938. He served as a radio operator in the US Navy during World War II.

White was an avid DXer, con-tester and CW enthusiast whose fist was familiar to thousands of hams. Active in the First-Class CW Operators' Club, White was inducted into the CQ DX Hall of Fame in 1998. He also was a member of the A1 Operator Club.

Survivors include his wife Ellen, W1YL, and his son Jim, K4OJ, both former ARRL staff members. - *via ARRL Letter Online 11/22/02*
