# Jack Edwards, W4DXJ, Silent Key



### Jack Edwards, W4DXJ, (SK)

Everyone that knew Jack was sadden to hear about his passing, April 8, 2007. He was featured in the September 1999 issue of *Ham Chatter* so I will not repeat much of that. It can be seen on the club web site at http://www.w4amc.com/ hc/pdf/hc9909.pdf.

Jack received his call sign, W4DXJ, in 1954 and was very active on the air. He assisted in emergency communications during Hurricane Hazel in 1954 and his dad almost fired him from his job at his dad's store because he was "playing on the radio". He was on the radio so much that he said that his wife, Rachel, told him to go back fishing!

He attended Greenville City Schools, graduated from Greenville High School in 1942, served in the US Army during World War II and earned the rank of Second Lieutenant at the age of 20. After his service, he returned to North Carolina, enrolled at UNC, and married the love of his life, Rachel Fleming. Jack graduated in 1949 with a degree in journalism. He later received a Masters in Business from East Carolina College.

Jack began his business career as manager of his family business, Edwards Auto Supply. In the late 1950's he joined the faculty in the Business Department of East Carolina and later served as Placement Director. In 1963, he and Rachel opened the Book Barn in downtown Greenville. In 1968, they established the University Book Exchange, which has grown to be one of the most successful privately owned college bookstores rica

in America.

Jack, who was an avid Rotarian for over 50 years, served as the 1980-1981 Governor of District 773. He was a founder of the Greenville Noon Rotary Club in 1981.

Perhaps the most enthusiastic fan in ECU history, Jack was a charter member of the Century Club, now Pirate Club, founded in 1963 and he was a life member. As a life-long swimmer, Jack won many state championships and held many state records in the North Carolina Senior Games. He was a charter member of the St. James United Methodist Church and was active for over fifty years.

Surviving are his wife of 59 years, Rachel Fleming Edwards; daughter, Nancy Edwards; son and daughter-inlaw, Don and Judy Edwards; grandchildren, Jack, Meredith, and Claire Edwards; sister, Mabel E. Minges; and nieces, Terry Minges Bryant and Connie Minges Bond.



### Jack Edwards, W4DXJ, SK

I first got to know Jack when I worked in Greenville in 1954/55 at WNCT-TV. We talked on the radio on 75 meter AM quite often (no 2 meter FM back then) and I visited Jack and Rachel when they lived on Shady Lane in Greenville. I remember sitting on the front steps with him talking about ham radio while their children, Nancy and Don, played in the front yard.

He would tease Rachel about a popular song at the time titled, "The Naughty Lady of Shady Lane". He would just forget about the last line of the song, "And she's only NINE DAYS OLD!!!"

Jack would help anyone if he

saw the chance. In 1980, I had bought a VW in Vanceboro that needed some work before I could drive it back to my home in Conover, NC. I bought it over to Greenville for repairs. I called Jack from the dealer and told him I was in town waiting for my car. He asked if he could come over to pick me up and spend some time together. Of course I said yes. He had a little 2 seat sports car and I road around town with him while he was doing some business. Then he had to teach a class at college so he told me to drop him off at ECU and I could keep the car for the rest of the day. I called his son, Don, later that afternoon and he came over to pick up the car. The VW was not ready so I had to get a ride back to Vanceboro and back the next day to get the VW. Jack said I should have kept his car overnight!

Back in July 1975, Jack invited a lot of his Amateur Radio friends down to his cabin on the Pamlico River near Bayview and it was like a small hamfest. He furnished the BBQ, other fixings and beverages for a great meal. I don't remember how many were there but it seemed to be around 40 to 50. He just wanted to entertain his ham buddies and have a good time meeting face to face.

I took some slides of the gathering and a dozen are now posted on the club web site. Some of you might recognize some of the old timers, although several are not with us now. Some in the pictures are present BARC members including Honorary members, Heber Adams, W4GDF and Charlie Wells, K4SKI.

Jack's son, Don, talked about how he liked to joke around. He went swimming several times a week and once when he was talking to several friends at another location, a lady that also swam at the pool the same time as Jack, came up to the group. He ignored her a few moments for everyone to gather around and then Jack said to the lady, "I'm sorry. I didn't recognize you with your clothes on!"

Jack once told me that the three R's were most important in his life. They were in order, Rachel, Rotary and Radio.

Jack will be missed by many. He was always the sunshine wherever he was but he made others feel that they were the sunshine. - *W4YDY* 



## **ARRL Update on Red Cross Background Investigations**

N E W -INGTON, CT, Apr 16, 2007 --

In March, the ARRL posted its position statement regarding the American Red Cross background check policy for volunteers. This updates information the League has obtained about that program.

ARRL General Counsel Chris Imlay, W3KD, and Chief Technology Officer Paul Rinaldo, W4RI, met March 20 at American Red Cross offices in Washington, DC, with two attorneys from the Red Cross General Counsel's office and two management-level staff members from Red Cross Disaster Services.

ARRL asked the Red Cross staff if ARRL ARES volunteers would be subject to the American Red Cross background check if they are providing communications for more than seven days. The position of the Red Cross is that ARES volunteers would not be permitted to provide communications at a disaster site for more than seven days without

submitting to the Red Cross background check procedure.

Discussion was then held regarding the Red Cross announcement that credit checks and mode-of-living checks would not be conducted. ARRL's stated concern was that the ARC background investigation consent form states that a consumer report and/or an investigative consumer report -- which includes certain credit checks and includes mode of living checks -- will be obtained on the volunteer signing the form.

The ARRL team asked if the Red Cross would be willing to modify the consent form so that it limits the authority granted by the person signing the form to criminal background checks only. The Red Cross representatives did not indicate a willingness to modify the consent form.

The ARRL team also suggested alternatives to the Red Cross investigation firm, MyBackgroundCheck.com. ARRL was given an indication that the Red Cross is also unwilling to accept background checks conducted by other entities, because the Red Cross would be required to compare the methodologies of its selected entity with those of the alternative background-check provider.

ARRL reiterates its recommendation that members carefully review any consent document permitting a private organization to conduct a background investigation on that person. The current Red Cross background check consent form does include permission, without further consent from the volunteer, to conduct a consumer report and/or an investigative consumer report. The Federal Trade Commission and Federal statutes define investigative consumer reports as including a mode-of-living check as well as certain credit checks.

ARRL will not suggest what organizations or agencies should or should not be supported by volunteer Amateur Radio communications. ARRL does wish to facilitate the provision of volunteer services, however.– *via ARRL.ORG*



# **Application surge continues under** new Amateur rules

It's been just a little more than two months since the FCC dropped the requirement that Amateur Radio applicants pass a Morse code test to earn operating privileges below 30 MHz. While the initial avalanche of applications immediately following February 23, when the no-Morse testing regime went into effect, has abated somewhat, business remains brisk for the ARRL Volunteer Examiner Coordinator staff.

"It's slowing down a little bit, but it's still substantially above what we usually see," observed ARRL VEC Manager Maria Somma, AB1FM. She estimated that new Amateur Radio applications were up by 35 percent, while upgrade applications were up by 150 percent over last year's volume.

In a typical pre-February 23 week, Somma said, ARRL VEC would receive paperwork from approximately 115 test sessions. "It's on the order of 150 to 200 sessions per week now!" she exclaimed. Somma and ARRL VEC staffers concurred that applications were roughly evenly split between newcomers and upgraders. She said she's also seen a spike in the number of applications from General and higher class radio amateurs to serve as volunteer examiners.

To satisfy his own curiosity, ARRL member Tommy Gober, N5DUX, compiled some FCC statistics on the number of new Technician, General and Extra licensees before and after the Morse code requirement was deleted. His numbers show the FCC issued nearly 700 more Amateur Extra, 3625 more General and 454 more Technician licenses in March 2007 than in the same month last

vear.

Figures from ARRL member and ham radio statistician Joe Speroni, AH0A, indicate the total number of Amateur Extra licensees is up 1649 from March 2006 to March 2007, while the General population grew by 2668. The total number of Technician licensees dropped by 1632 during the same period, however -- and it continues to drop going into April.

Speroni's figures also show that the grand total of Amateur Radio station licenses has declined by more than 12,800 over the past two years -- to 655,048 at the end of March.

The still-heavy volume has stretched the amount of time it takes for an application to proceed from examination session to license grant. "I think we're looking at eight to ten days from the test date," Somma allowed. By and large, those on the waiting end have been patient and understanding, she added.

A staff of seven full-time and three part-time employees handle the "incoming" from Amateur Radio exam sessions across the US and from other sites where US Amateur Radio examinations are administered through ARRL VEC.

There's no light at the end of the tunnel just yet. Somma and her staff are looking ahead to 450 examination sessions registered for May, another 400 in June and 320 apiece during July and August. And summer is "the slow season." she remarked. Another 900 test sessions already are on the calendar for the rest of 2007. - via ARRL Letter Online 4/27/07

## Rough seas slowing Scarborough Reef (BS7H) DXpedition team

The Scarborough Reef (BS7H) DXpedition team <http://www. scarboroughreef.com/> will not be hitting the airwaves quite as quickly as expected. Extremely rough seas were slowing the progress of their vessel and now estimates it will arrive on Scarborough Reef Sunday morning local time (UTC = local time minus 8 hours). At 0240 UTC on April 27, the team was located some 240 nautical miles northwest of Scarborough Reef and making less-than-expected progress. The sea has been rough since departure, and there has been no maritime mobile operation. The multinational team from the US, Europe and Asia says on its Web site that it's "poised and prepared to ensure that every DXer gets a chance to make a QSO with this rare entity." Headed by ARRL Pacific Division Director Bob Vallio, W6RGG, the crew left Hong Kong April 25. Under normal conditions, the vovage takes approximately two and a half days. Upon their arrival team members will immediately assemble gear, erect antennas and announce on the Web site when operations commence. The team plans to follow propagation forecasts as closely as possible and concentrate on the bands that should provide the highest productivity to the Americas and to Western Europe. It was decide to try and dispose of the equipment asap if there was no immediate need for it because we have no room to store it and someone else may be able to use it. The concept of a Disposition Committee was brought up.
