In order to have meeting on line, we all need to download the Zoom app to our smart phones (iPhone & Android), iPads and computers (Mac or PC) and sign up with your email to get a free (AKA "Basic") membership number. I have signed up for the Pro version so I run the meetings or can set up one other to run the meeting.

Once you have your number, send me the email address you used to sign up and the member number (that looks like a phone number). There are many video tutorials on line to teach you how to use zoom. It is easy as eating pie! We have just had our first BARC Board meeting on line with 9 of us without problems. Our license allows 100 members in the group. You will need a good internet connection so do not stream Netflix or other internet things while on zoom as zoom needs as much bandwidth as it can get. A wired connection from







#### Some Countries Permitting "STAYHOME"-Suffix Call Signs during COVID-19 Pandemic

Some countries around the world are allowing radio amateurs to use special "STAYHOME" call sign suffixes. For example, listen for 8A1STAYHOME from Indonesia, and A60STAYHOME/# call signs from the United Arab Emirates.

In Canada, Michael Shamash, VE2MXU, is using VC2STAYHOM "to raise awareness for social distancing during the COVID-19 pandemic." Canada limits call sign suffixes to seven characters.

#### To All ARRL Members and ARRL VEC Accredited Volunteer Examiners

We know many examiners have canceled amateur radio license exam sessions to meet the requirements and recommendations of national and local government and of health officials. The health and safety of examinees and our Volunteer Examiners (VEs) is first and

foremost in any decision-making process. The ARRL Volunteer Examiner Coordinator (VEC) does not offer video-supervised online amateur radio licensing exams at the present time. We are aware, however, that some VE teams are exploring alternative formats on a local

basis. Please use ARRL's

License Exam Search to find scheduled exam sessions in your area and verify with the local exam team that the session is still being held.

The ARRL VEC is continuing to process license examination materials from VEs who have completed exam sessions, although some delays may occur under the circumstances. The ARRL data to the FCC for qualified examinees.

We understand that some examination candidates are continuing their studies toward new amateur radio licenses and license upgrades. We also know some will be frustrated that, at this

> time, the ARRL VEC does not offer online licensing exams.

> > Amateur radio is not alone this challenge, though.

While each of us continues to respond to the immediate evolving crisis, we also know that we must keep an eye on the future. Throughout its decades of service, the

VEC system has served the FCC as a shining example of the successes of a privatized system. The ARRL VEC and our VEs are recognized throughout the Amateur Radio Service for our integrity and efficiency. Adapting our all-volunteer license examination administration will be a challenge, but it's a challenge we are committed to undertake

VEC electronically forwards all required in order to advance the program and improve service.

> While we face unprecedented challenges, opportunities also await. We are grateful to support radio amateurs in our common pursuit of skill, service, and discovery. #### May QST Going Out to Members on Time, W1AW Adjusts Its Schedule



ARRL wants to assure members that the COVID-19 shutdown of ARRL Headquarters have little or no impact on publication schedules. The print edition of May QST is now off the presses

and will enter the mail stream next week, and the US Postal Service anticipates no delivery disruptions.

Digital QST and the pending digital debuts of QEX and NCJ are expected to be posted on schedule. May QST will include more details on the QEX and NCJ digital editions — a new member benefit — as well as an intriguing cover article on "The Lightbulb QSO Party."

ARRL also anticipates that The ARRL Letter, ARRL Audio News, the ARES E-Letter, The ARRL Contest Update, and the Eclectic Technology podcast will be available as usual.

Although ARRL Headquarters is closed, W1AW continues operating, but on a slightly altered transmission schedule. Morning code practice and qualifying run transmissions have been suspended; evening transmissions, including qualifying runs, will go on as usual. W1AW remains closed to the public, however.

### Field Day 2020 — A Time to Adapt



Many individuals and groups organizing events for Field Day 2020 have been contacting ARRL for guidance on how to adapt their planned activities in this unprecedented time of social distancing and uncertainty.

"Due to the unique situation presented this year, this can be an opportunity for you, your club, and/or group to try something new," ARRL Contest Manager Paul Bourque, N1SFE, said. "Field Day isn't about doing things the same way year after year. Use this year to develop and employ a new approach that is in line with the current circumstances."

Social distancing and state and local requirements very likely will impact just how — and even whether — you are able to participate in Field Day this year. ARRL continues monitoring the coronavirus situation, paying close attention to information and guidance offered by the Centers for Disease Control and Prevention (CDC). If social distancing means that Class A with a 30-member team set up in a city park won't work this year, then it's time for a Plan B. Part of the Field Day concept has always been adapting your operation to the situation at hand. At its heart, Field Day is an emergency communication demonstration. Field Day rules are flexible enough to allow individuals and groups to adjust their participation and strategies in a way that still addresses their needs while being fun. Some possibilities:

Encourage club members to operate from their home stations on emergency power (Class E).

Use the club's repeater as a means for individual participants to keep in touch during the event.

Family members interested in operating Field Day and unable to participate as part of a larger group may want to consider setting up a portable station in the backyard with a temporary antenna.

One big impact this year will be a decline in public visibility and any

interaction with the visitors. Prudence may dictate dispensing with the ham radio PR table to attract passersby, should you set up in a more public location. It's okay not to score all the bonus points you may have attempted in the past. Local and served agency officials may be unwilling to visit, which is understandable under the circumstances. Do be sure to reach out to them as part of your preparations and remind them that you look forward to continuing your working relationship with them in the future.

The impact will differ from place to place, so ARRL recommends that all amateur radio clubs participating in Field Day stay in regular contact with local or state public health officials for their advice and guidance on hosting Field Day activities.

Demonstrating an understanding of the health crisis we all face and your willingness to adapt will show that you and your club or group are good working partners with local or served agencies.

"With any emergency preparedness exercise, it's not about adapting the situation to your operation, it's about adapting your operation to the situation that presents itself," Bourque said. "Try something different. Learn something new about how you prepare. It may be a challenge, and you may have to ask yourself if you're up to the challenge. We hope to hear you on the air over the June 27 – 28 weekend." — Thanks to Paul Bourque, N1SFE, and Dan Henderson, N1ND - via arrl.org 03/27/2020

## **Zoom Safety Information — by N4PVH**

from members
about the flaws
of using zoom
app for our meet-

ings. I would like to address the valid concerns and appreciate everyone looking out for the safety of the group. Here is the situation as I can gather from multiple news outlets and IT experts:

1: About a year ago someone got into an open (no pass word) meeting and interrupted the meeting by making sounds or drawing on the screen obscene figures. They were kicked off of the meeting. This news story keeps re-surfacing on the internet when it is very old news and should have died a long time ago.

Remedy: Have a pass word to prevent unwanted attention. Send invites only to membership. We have that on our meetings.

2: Other hackers got into a meeting uninvaded more recently.

Remedy: Have a virtual "waiting room" and admit members from there to the meeting by the administrator of the meeting. We have that on our meetings.

3: Some malicious individual with serious hacker skills send a chat message to another member in the same organization that had malicious code causing that person to leave the meeting.

Remedy: There is no remedy for malicious behavior but the damages were minimal (left the meeting or was sent to a malicious web page where the individual could click on something they should not, to download a virus on a PC). This action needed the following events to be able to do this: 1: the malicious individual needed to be registered to the same organization as the first individual ( in other words be part of the same corporate internet with the same email server). 2: Needed to know the victim's email and

password. 3: Needed to be registered in the same meeting as the victim. This sounds like a feud between two corporate employees. This is not likely in our meeting as none of these conditions apply.

4: That installing the zoom software also puts an internet server secretly into the background processes of the MAC computers so that if you delete the app, it reinstalls itself without your permission.

Remedy: I have gone into "Terminal" (Unix shell commands) and poked about to find the specific location of this "supposed server app" and found nothing. It does not behave in the way it was claimed. Possibly false news as it was made public by the media that is owned by Microsoft. OK, we can get into conspiracy theories if you want but lets let it die there. Zoom has constantly upgraded the software like all software companies as their lifeblood is good experiences for the users. Not to find problems and improve the product would be suicide for a software company. Get the latest version and you will have the best protection you can have as nothing is absolutely secure on the internet. The only way to be absolutely secure is not to connect to the internet.

5: Zoom gave the school systems unlimited access as a gift to allow them to continue to teach our children at home away from Covid19. The unforeseen growth of this and others jumping on zoom is that their user group grew by 200 million users suddenly. This puts a very significant strain on resources for them and they are trying to deal with this. "No good deed goes un punished?"

I investigated many of the other meeting apps and have attended many other on line seminars and have found that none are secure and that zoom seems to be the best at it and simple to maintain. The other programs that are "free" are only that way for 3 months or have other agendas like they want you to use their other apps (spread sheets and the like that we do not need.) Also we are not talking about proprietary information, most of

this is freely available on the internet anyway so it has no profound risks.

Summary: I cannot and will not guarantee anything and you are taking your own risks (just like going to the grocery store to get food is a risk that might kill you) but you have two choices: 1: Do not install the software and do not attend or go on the internet or 2: keep your antivirus software up to date and the other apps up to date. Enjoy the meeting and participate. Viruses of all kinds are evil whether they be biological or logical, this is the real world!

Hope to see you at the meeting as the preview of the Amelia Earhart presentation on Zoom was very interesting and thorough. Enjoy it whether we have problems or not.

#### Spain Grants Unlicensed Individuals Permission to Use Amateur Stations During Lockdown



Spain's International Amateur Radio Union (IARU) member-society URE has obtained temporary permission from the country's telecommunications regulator for unlicensed people to use amateur stations during the coronavirus lock-

down.

"The main objective of the request is to disseminate and promote amateur radio among schoolchildren who must be confined at home," the announcement from the Ministry of Economic Affairs and Digital Infrastructure said. "This activity offers young people the opportunity to gain practical experience in telecommunications technology, promotes education in technological subjects, and is a socially enriching family activity."

The temporary authorization would be in place while the state of alert and mandatory confinement measures are in effect in Spain. 



ARRL Headquarters will comply with an executive order from Connecticut Governor Ned Lamont that all nonessential businesses and notfor-profit entities reduce inperson workforces by 100% no later than March 23, 2020, at 8

#### FCC Levies \$18,000 Fine on Louisiana Amateur Radio Licensee



In an enforcement case prompted by complaints filed 2017, the FCC has i m p o s e d \$18,000 forfeiture

on Jerry W. Materne, KC5CSG, of Lake Charles, Louisiana, for intentional interference and failure to identify. The FCC had proposed the fine in a Notice of Apparent Liability (NAL) in the case in July 2018, and, based on Materne's response to the NAL, the agency affirmed the fine in a March 12 Forfeiture Order (FO).

As the FCC recounted in the FO, an FCC agent "observed Materne causing intentional interference to a local repeater by generating digital noise into an analog radio." The agent further reported that Materne failed to transmit his call sign, as required.

Materne disputed the FCC's findings, arguing that the NAL should be canceled because the agent "was mistaken in his determination that the source of the interference was Materne's station" as his radio was not capable of operating

on the repeater frequency in question, the FCC said in the NO. Materne also asserted that he is unable to pay the fine and suggested in his response that the FCC should be able to access his financial information.

The FCC countered that the radio the agent observed in Materne's possession was capable of operating on the frequency in question. "We therefore are unpersuaded...that the proposed forfeiture should be cancelled because, he alleges, he was not the party causing interference to the repeater and the radio in his possession could not operate on the frequency in question," the FCC said in affirming the findings of the NAL. "We are also unpersuaded by Materne's argument that he lacks the ability to pay the full \$18,000 forfeiture." The FCC said Materne failed to provide the FCC with proof of inability to pay, as required by the NAL.

The FCC gave Materne 30 days to pay the fine, or face having the case turned over to the US Department of Justice for enforcement. - via arrl.org 03/18/2020
