# SILENT KEY Jim Hecker, KD4VBX

Our fellow ham and member of the Brightleaf Amateur Radio Club, James Arthur Hecker, KD4VBX, became a silent key on July 13, 1997 at the age of 77. He died at his home in Greenville, NC

Jim was a native of Glendale. NY and attended New York City schools and went to the University of Mississippi and New York University. He was in the army from 1942 to 1946 and served in the judge advocate general's headquarters in Cairo, Egypt.

Jim was an industrial engineer and he and his family moved to Greenville in 1964 with Empire Brushes (now a Rubber Maid plant). He retired as plant manager in 1995. He was active in the US Coast Guard Flotilla and was a Boy Scout leader and council member for 20 years.

Jim got his ham license late in life at the age of 72 getting encouragement from Jack Kear, K4MI, and Simon Jaworski, KQ2V. He got his Technician Class 12-29-92 As his son Brian puts it, "He had time on his hands and money in his pocket." Jim had an interest earlier in his life having saved a telegraph key from when he was much younger. His latest upgrade to General Class was on 8-2-95. His son Steve noted that he enjoyed meeting people on the air. Brian added that he was also interested in the welfare side of amateur

## FCC OPENS VANITY GATE 3

The long wait is over for Advanced class amateurs. The FCC has announced that it will open filing Gate 3 of the Vanity Call Sign Program on Inside This Issue Wednesday, August 6, 1997. Advanced class hams will be able to apply for a call sign appropriate to their license class on or after that date. Applicants must file either a paper FCC Form 610V or electronically via the FCC's Web site at http://www.fcc.gov/wtb/amradsrv.html and pay the current \$30 fee.

The August 6 deadline squeaks under the implementation of the FCC's new fiscal year 1997 fee schedule, adopted June 16. Under the FY 97 schedule, which becomes effective September 16, 1997, the vanity application fee will jump to \$50 a year. The ARRL had asked the FCC to suspend implementation of the higher FY 1997 fee until after the remaining gates have been opened and applicants had an

## Twenty Meters Opens for Queen's Amateur Radio Debut

As if by royal decree, a sluggish 20 meters suddenly opened between St John's, Newfoundland, and Bristol, England, on June 25 as Queen Elizabeth II became the first reigning British monarch to speak over ham radio. Paul Piercey, VO1HE, president of the Society of Newfoundland Radio Amateurs which arranged (SONRA), the transmission between VO500JC and GB500JC, said band conditions had been "quite poor" immediately prior to the event. "It was not known if the contact would be made," he said.

But when the appointed hour arrived, Piercey said, "it was almost as if the path opened up and, at 1801 UTC, the contact was made." The response from Martyn Phillips, G3RFX, on the Bristol side "was quite loud, despite the poor conditions," Piercey reported. He and Dan Goodwin, VO1MX, assisted the


Queen on the Canadian end of the QSO, while Phillips, Cyril Chapman, G2HDR, and Robin Thompson, G3TKF, responded on behalf of the people of Great Britain.

The occasion was the 500th anniversary of the "Voyage of Discovery" to the New World by explorer John Cabot in 1497. VO500JC was located in Cabot Tower on St John's Signal Hill, which, in earlier times, served as a signaling post to announce approaching ships to the city's merchants. The VO500JC QTH also was just a few hundred feet from the site where Guglielmo Marconi received the first wireless transatlantic signal on December 12. 1901. The Oueen referred to that accomplishment in her brief remarks over the air and added, "I am happy to know that Newfoundland and Labrador is forefront still in the of the communications industry and is working closely with other leaders in this field across the Atlantic."

SONRA is planning to host a celebration to mark the 100th anniversary of Marconi's historic accomplishment in December 2001

On the Canadian side, the equipment used was a Kenwood TS-850SAT, a Heathkit SB-200 amplifier running approximately 400 W and a simple wire dipole about 20 feet above the Powder Magazine, an outbuilding which served as the shack. It would be a shock to them when they started to renew and found out they had to take the exams again and might have to pay the FCC \$30 (it goes to \$50 on September 15) to get their call back if it has been more than two years! With all the address changes going on in Pitt County now for the 911 system, there are a lot of address changes. I sent my FCC Form 610 in and had the new license in less than two weeks. It just cost one stamp. If you fall in this category, it would behoove you to take the time to send in a modification on a 610.

Email was received from Tony Clifford, EI9HK, Cork, Ireland with some nice comments about the BARC Internet site. He has linked the BARC site to his home page so he can check it often. With Ham Chatter on the Internet, Amateur Radio operators from around the world can keep up with the latest from the Brightleaf Amateur Radio Club and Greenville Amateur Radio activities. The latest BARC Field Day pictures were put on the Internet on July 3. Nice comments were also received from other Amateurs in North Carolina.

#### K2BSA WORKS MIR FROM NATIONAL JAMBOREE

The Boy Scouts' K2BSA -- on the air from the National Scout Jamboree at Fort A. P. Hill, Virginia -- had a successful 15-minute chat with US astronaut Michael Foale, KB5UAC, aboard the Russian Mir space station on August 1. "Everybody here could hear him perfectly," reports HQ staff member and Scout Leader Larry Wolfgang, WR1B. "He came over the horizon calling us."

The QSO began shortly before 5 AM Eastern Time. Wolfgang said it was still dark enough to get a visual sighting of the Mir.

Wolfgang said some 150 Scouts and leaders were on hand for the earlymorning Mir QSO, and a few Scouts got to talk with Foale. MIREX chief Dave Larsen, N6CO, arranged the Mir contact. At the Jamboree, Chris Anderson, NK8W, was the operator. Jim Ingle, N4PBX, assisted him by programming the Doppler shift into the transceiver's memories.

> MirThe contact was the

highlight of the "tons of radio activity" at the Jamboree, Wolfgang said. He reports that 238 Scouts began work on the Radio merit badge, and 89 have completed it by August 1.

"A new activity is the daily excursion of our 'Jambo Rover' -- our own version of the Mars Rover," Wolfgang said. "It's a remotely-controlled vehicle with an ATV station on board." Wolfgang said the ATV and packet link between the Radio Merit Badge Booth and the K2BSA station continues to be very popular.

#### FCC reminder

The FCC is warning companies that offer to modify scanning receivers (this includes many H-Ts with extended receive coverage) in order to receive cellular telephone frequencies that this activity prohibited by federal law and FCC rules. The FCC's reminder, issued July 10, noted that scanning receivers must be FCC-certified and incapable of "readily being altered by the user" to pick up the cellular bands. "The modification of scanners on a substantial scale to receive cellular frequencies will be considered to constitute manufacture of such equipment" in violation of federal law and FCC rules, the Public Notice said. "Entities engaged in such activity are cautioned to cease advertising and/or performing any such activity immediately." - FCC - via ARRL Letter Online- 7/11/97

opportunity to file under the old schedule. The FCC's response, buried within the Report and Order adopting the higher fees, suggests the FCC could also be planning to open Gate 4 fairly soon. "We expect our remaining vanity call sign 'gates' to open before the effective date of our FY 1997 regulatory fee payment requirement," the FCC said in turning down the request for a delay. But, the FCC added that applicants "are expected to pay the fee applicable at the time they file." The bottom line is that hams applying for a vanity call sign on or after September 15 must pay the \$50 fee.

Payment of fees may be made by check (payable to FCC), bank draft, money order or credit card. If paying by credit card, you must also complete and submit FCC Form 159 with your FCC Form 610V. Do not send cash. Send your application package to: Federal Communications Commission, Amateur Vanity Call Sign Request, Box 358924, Pittsburgh, PA 15251-5924.

If you file a paper application, remember that legibility is critical! If your application is not able to be deciphered easily by FCC personnel, you could experience a delay in processing, lose the opportunity to obtain a requested call sign or even obtain a call sign different from what you want. Be sure to include your current Amateur Radio call sign on your vanity application.

Under Gate 3, you must hold an

unexpired Advanced class operator/primary station license to request a vanity call sign for your primary station. To request a vanity call sign for a club station under Gate 3, you must also hold an unexpired club station license grant listing you as the license trustee. Applicants should refer to the licensee database to verify that a requested call sign is not already assigned. A call sign is normally assignable two years following license expiration, surrender, revocation, set aside, cancellation, void ab initio, or death of the grantee.

Using Form 610V or its on-line electronic equivalent, applicants may request up to 25 call signs in the order of preference. The first assignable call sign on the list will be the one the FCC assigns. Remember: When requesting a call sign under Gate 3 for your primary or club station, the call sign must have been unassigned for at least two years. As an Advanced class operator, you may request

a call sign only from groups B, C or D.

Any call sign requested must be one designated for the region of your mailing address, as follows:

One of the contiguous 48 states: Regions 1 to 10.

Alaska: Regions 1 to 11.

American Samoa: Regions 1 to 10, or Region 13 having numeral 8.

Commonwealth of Northern Mariana Islands: Regions 1 to 10, or Region 13 having numeral 0. Guam: Regions 1 to 10, or Region 13 having numeral 2.

Hawaii: Regions 1 to 10, or Region 13 having numeral 6 or 7.

Puerto Rico: Regions 1 to 10, or Region 12 having numeral 3 or 4.

Virgin Islands: Regions 1 to 10, or Region 12 having numeral 2.

For explanations of Groups B, C and D and the geographic regions, see Fact Sheet PR5000 Number 206S, Amateur Station Sequential Call Sign System (or see The ARRL Letter Electronic Update, August 16, 1996, available on the ARRLWeb at http://www.arrl.org/). For more information on the vanity call sign program, see Fact Sheet PR5000 Number 206V Amateur Station Vanity Call Sign System.

If you file before the opening date or do not qualify under the Gate 3 eligibility standards, your application will be dismissed. General, Technician Plus, Technician, and Novice class operators will become eligible to request vanity call signs under Gate 4. The FCC has not indicated when it plans to open Gate 4.

#### **ELECTRONIC VANITY APPLICATIONS TO GET PRIORITY**

When vanity call sign Gate 3 opens on August 6, 1997, the FCC will process electronic applications ahead of paper applications each day. Previously, the FCC did not distinguish in how it handled electronic and paper Form 610V applications. In recent months, the FCC has been receiving more electronic applications than paper applications. The FCC says it will process electronic applications, then paper applications received on any given day.

The FCC also has established a firm deadline for receipt of application fees to accompany electronic applications. After Gate 3 opens, fees for electronic applications must be received by the FCC's fiscal agent, Mellon Bank, within 10 days of the date of application or the application will be dismissed. The fee will remain at \$30 for the ten-year term until September 15, 1997, when it will increase to \$50 for the ten-year term.

Applicants can find the electronic Form 610V on the FCC's Web

site at http://www.fcc.gov/wtb/amradsrv.html. Electronic applications require a Form 159 for any method of payment. Mail payments accompanying electronic applications to Federal Communications Commission, Box 358994, Pittsburgh, PA 15251-5994.

Paper applications require an FCC Form 159 if payment is by credit card or if the application package contains multiple applications being paid for with one check. Individual

Harry Mueller, KC5TRB, in Tulsa, Oklahoma, reports working Foale July 21 on 145.985 MHz FM voice. KC5TRB responded to KB5UAC's CQ. Mueller that Foale said he disappointed that this crew would not get to make the needed Mir repairs, but that he was in "good spirits." Mueller said that Foale "sends his best wishes and a big thank you to the Amateur Radio community" for its support during the Mir crises. From Melbourne, Australia,

Chris Edmondson, VK3CE, reports connecting with the ROMIR packet system July 22 on 145.985 MHz and "good copy for the entire high pass of almost 14 minutes." Foale told MIREX CEO Dave Larsen, N6CO, on July 21 that he was having frequent power problems with the TNC and losing messages. "Sorry. No supply store is near at hand," Foale guipped, adding that he was getting ready for the next Mir crew to arrive on August 7. applications do not require a Form 159 if payment is by personal check or money order. Send paper applications containing payments to FCC, Box 358924, Pittsburgh, PA 15251-5924.

To avoid processing delays, applicants should make sure the information on their license is up to date. If you have changed your name or address, you must file Form 610 with the FCC to request modification of your license to show the correct information. In the case of a club station, you must file Form 610B.

Gate 3 opens the vanity call sign program to Advanced class amateurs. The FCC has not said when it will open Gate 4, for General, Technician Plus, Technician and Novice class operators.
