



I'm sure everyone is very pleased that Brother Simon, KQ2V, will continue to lead the BARC VE team. Be sure to read his article in this month's Ham Chatter.

The American Radio Relay League's proposal to dumb down the Amateur Radio licensing program has many Amateur Radio operators upset and many are happy about it. A lot of the happy ones will be able to get a higher class of license without having to put out

much effort if the ARRL gets its wish. The ARRL wants a maximum 5 WPM code test even for the Extra

Class license. If the VE program is not changed to eliminate the written exam for the code test, there will be wholesale cheating in some areas. All they have to do is to get their hands on only one set of code exams and get the 10 answers for each exam. With 13 and 20 WPM tests gone, they would not have to cheat as many times. The only way to completely eliminate the code test exam cheating is to end written exam for code exams. That's what I have let my ARRL Division Director, the ARRL and the FCC know. Before the VE program was started, the only requirement was to copy one minute solid out of the five minute exam. I hope the FCC will listen, because the ARRL is not. They hear, but they also let you know why they are right because they believe if the FCC will make it easier to get a license, Amateur Radio will survive. I disagree. At the direction the ARRL is going, in a few years, Amateur Radio will become like CB radio and there will be so much

breaking of the regulations that the FCC will be overwhelmed. That's when the commercial people will come in and take the bands away from Amateur Radio. Money talks!

I wonder how many BARC club members work any of the many contests on the air every month. If you haven't tried it, you should at least try one time. But there is a danger. You might get hooked! I enjoy working some of the contests for fun. I don't do it to try to win, but just to see how many stations I can contact in just a few hours and help give points to others. A couple of weeks ago, I made 100 contacts and picked up many states and VE sections on 75, 40, 20, 15 and 10 meters in about four hours over a 30-hour contest. It was the ARRL SSB Sweepstakes and it's a great way to get the hard-to-find states. I worked all 50 states one weekend a few years ago.

> Only worked 36 in the last contest. I guess all of the contesters that are trying to win get

all 50 several times each contest.

Also, it's a lot of fun to work the DX contests. One that can put in enough hours over a 48-hour contest weekend, it is not hard to contact more than 100 countries. I always wanted to get a DXCC award, but I never took the time to make the contacts. After I entered all my logs into a computer log, I found that I had contacted 99 countries from 1952 to 1991. After I moved to Greenville in 1962, I started to work some of the contests. Although I just operated for a few hours in each contest. I had contacted more than 100 countries by 1963 in a couple of contests. I know it's not much for the real contesters, but I enjoy making a few contacts just for fun. When there are pileups, I will try for a max of about five minutes and if I don't have any luck getting in, I just move on and contact other stations. I use a computer log connected to the radio to make time and frequency entries automatically. Having

board (to dumb down). It was labeled as informal and unreliable. Again... nibble, nibble, nibble... As a result of all of this nibbling, the directors voted what they wanted without properly soliciting the opinions of the larger membership. hey stated they had to make the hard decision for the good of Ham Radio. Our most recent national elections reflect the same arrogance of knowing what's right for all of us while ignoring the electorate... Nibble, nibble, nibble... And lastly are the nibblers who have tried to circumvent the necessity of mastering all of the elements that are required for earning an amateur license. In the last year or so, I have come to learn that eastern North Carolina is no different in this regard from many other areas in the country. Again, nibble, nibble, nibble...

Two months ago I resigned my membership in the League after almost 30 years and considered doing the same concerning my involvement in the volunteer examiners program. The decision to resign has been determined essentially by the nibblers in our hobby and is of a private nature. My second decision to resign the VE program has a more public side to it.

I have been involved in the Volunteer Examiners program since 1984 starting in the Hudson Division and since 1990, here in Greenville. In that period of time I have acted as the VE liaison for the Brightleaf Club and as an Extra Class

examiner in all but 2 sessions sponsored by BARC since 1990. In that time, BARC has conducted 57 testing sessions serving 506 examinees, administering 912 test elements. These sessions have resulted in 246 new licenses or upgrades. In the time since 1990, there have been 3 Extra Class licenses, 20 Advanced Class licenses, 35 General Class licenses, 58 Tech Plus licenses, 127 Technician Class licenses and 3 Novice Class licenses issued by the FCC due to this testing. I have also participated in VE sessions in Kinston, Smithfield, Little Washington and Fort Barnwell.

In all of these sessions, the

examiners have been most diligent in making sure the scrutiny of the examination process has been without reproach. I have a special affection for the VE examiners who have participated in the testing process over the years, especially the Extra Class licensees who attended every session so that we could test beyond the Tech Plus license. Unfortunately, in recent years, some have moved away and some have passed on. Presently, there are only 4 Extra Class VE's who have been active in giving

examiner in all but 2 sessions sponsored by BARC since 1990. In that time, BARC has conducted 57 testing sessions serving 506 examinees, administering problem for many other clubs as well.

I have a particular aversion for all nibblers. In my best analysis, they do not belong in the hobby. Some amateurs have expressed an opinion that if the BARC test sessions are halted here in Greenville, then the local nibblers will have won the day. Others have expressed their concern and hope that these sessions continue and that I continue to be part of Discussing this with Dave, W4YDY, yesterday on two meters and having our conversation interfered with, I decided to continue to rail against the nibblers. I will remain outside the League because I do not see them as truly representative of our hobby, but I will remain active on a local level by continuing my involvement in the BARC testing sessions. I hope that my involvement will add to the reputation that my fellow examiners have earned through their diligence and fairness. Having said that, there are some issues which the club should consider concerning the VE program. To wit, we need more examiners and we need more higher class license to volunteer their time in this vital area.

In closing, I would like to quote N6WR, who recently opined concerning the dumbing down process. He wrote, "Granted, CW is not easy. Nothing worthwhile comes without effort. But, that is what sets the Amateur Radio operator apart. They took the difficult No whining. The goal was attacked with vigor and fervor." and "One League official wrote how the amateur is being left behind technically. Not so. Among those employed in electronics there are Hams at the top who

ECFS replaces RIPS

Editors note: This info should be of help to those that file comments to the FCC on rulemaking proceedings. -W4YDY

As of October 26, the FCC's Electronic Comment Filing System (ECFS) has replaced the Record Imaging Processing System (RIPS) as the main source for copies of documents filed in docketed and rulemaking proceedings. The public can view all ECFS documents at http://www. fcc.gov/e-file/ecfs.html. The public also can file comments electronically in unrestricted rulemaking and docketed proceedings. The ECFS is designed for use with Netscape ver 3 or higher or Internet Explorer ver 3 or higher. The FCC plans to add an FAQ page to ECFS to make the system more user-friendly. Aside **Extra**

Class

The FCC has notified four individuals that it is setting aside their recent Extra Class license grants and privileges while it investigates alleged irregularities in the volunteer examination process. Letters from the FCC went out November 10 to Elmer J. Smith, N3UNR, of Effort, Pennsylvania; Philip DiGenova, N3UNS, of Bartonsville, Pennsylvania; Wayne S. Bowden, AA3RT, of Millsboro, Delaware; and Kenneth L. AA3RU, of Boyertown, Pennsylvania, that the Commission was setting aside their Extra Class grants. All four individuals were requested to return their Extra Class license documents and Certificates of Successful Completion of Examination (CSCEs) to the FCC's Gettysburg office.

"This letter is not a finding that you have engaged in misconduct," the letter said, adding that if the FCC's investigation concludes that it should grant the Extra Class license applications, it will reinstate the grants.

An FCC official said the investigation was looking into testing irregularities including allegations that examinees might have been coached or given test answers. "They are bumped back for now while we investigate, since we had enough evidence at the outset to do that," he said.

For the time being at least, Smith and DiGenova have been bumped back to Technician class licensees, while Sharp will revert to Advanced class and his former N3TPN call sign. All three took their examinations October 6 at a W5YI-VEC session in Warminster, Pennsylvania. Bowden apparently never held a ham ticket prior to taking the examination elements for Extra Class at Spring City, Pennsylvania, on October 4 during a W5YI-VEC testing session. The call sign AA3RT no longer appears in the FCC database. The records of the other three amateurs involved were modified November 10. - Via ARRL Letter Online 11/20/98
