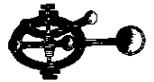

Amateur Radio Spectrum Protection Act of 1999 Introduced

It's round two in Congress for the Amateur Radio Spectrum Protection Act. At the request of the ARRL, Rep Michael Bilirakis introduced the 1999 version of the proposed legislation, HR 783, on February 23.

The bill is aimed at ensuring the availability of spectrum to Amateur Radio operators. It would protect existing Amateur Radio spectrum against reallocations to or sharing with other services unless the FCC provides "equivalent replacement spectrum" elsewhere. Bilirakis, a Florida Republican, also sponsored last year's measure, which attracted upwards of 83 cosponsors on both sides of the aisle. Rep Frank Pallone Jr, a New Jersey Democrat, is the initial cosponsor of the 1999 bill.

ARRL Legislative and Public Affairs Manager Steve Mansfield, N1MZA, says the 1999 bill "is largely the same as last year's HR 3572." The major difference is that the 1999 version adds "Amateur Satellite Service" frequencies to "Amateur Radio Service" in detailing the frequencies that would be afforded protection under the act.

Specifically, HR 783 would amend the Communications Act to require the FCC to provide "equivalent

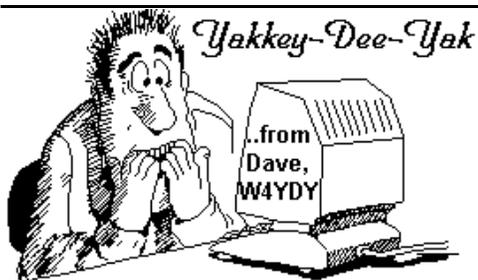


Yakkey-Dee-Yak

I was looking through my junk box a few days ago and came across a meter that I had forgot about. There have been some here that claim I was around when radio started and after finding one item in the junk box, he might be right after all. I tried to recall some of my early days in Amateur Radio and a transmitter that worked after a fashion.

Surely everyone is familiar with the old spark gap transmitters of the early days. Well I found my old spark gap meter manufactured by Campbell Electric Company in Lynn, MA! It is made of metal, not a piece of plastic in it. Don't know where the rest of the transmitter is. The picture of the meter might not be too clear but it does have across the top of the meter a scale name, "Spark Gap Inches". The readings go up to 6 1/2 inches but it looks like it would read a maximum of 7 1/2 inches for full power! Boy oh boy! When you had that thing kicking up to near maximum, you could be heard a long way off. The sparks were flying! It looked like a summertime thunderstorm. In the shack, it was best to wear ear and eye protection because even the neighbors from a block away would complain about the noise and bright flashes! That's why most hams lived out in the country. I had some great QSO's with some guy named Marconi in Italy!

It's amazing how much things have changed over the history of Amateur

Radio. It has gone from spark gaps to lasers. In the April issue of one of my ham magazines, there is an article using lasers for the antenna elements. With a contest coming up, I decided to try one. One of the best features is the simple way to change bands. For example, to change to 80 meters from 10 meters, I just increased the laser power by 8 times. To get to 160 meters, just double the power from 80 meters. To get your SWR to 1:1, just adjust the laser power while watching the SWR meter. It does not matter how high the antenna is mounted so that makes the installation very easy. The neighbors have told me how pretty it is at nighttime! A transmission line is not required.



Just use another laser to replace the conventional transmission line. When a thunderstorm comes up, there is not a transmission line to disconnect from the rig. When you turn your rig off, the laser transmission line is turned off! How simple can it get! In the recent WPX contest, I contacted stations from Australia to Winterville and got 59 plus reports.

Don't ask me how it works or how to make it work. I am going to keep that a secret! Just remember, this is the month of APRIL! - W4YDY



Good Buddy

In the wee hours of the other night while trying to make contact with an Alaska station, I was reminded of just how lonely ham radio can be. You may be talking with someone across town or the world, but there's nothing like having someone right there with you. I've used techniques such as talking to my self and competing against myself, but that's a poor substitute.

The answer came in a recent advertisement, you know those things you get in the mail just because you've a call sign. Maybe you've already been sent one too, but I thought it was important enough to let other people know in case they were missed. The product is called Constant Companion manufactured by Creative Plastics located in Ohio. What they've come up with is an inflatable person that will mimic specified characteristics. Before this there were more primitive versions which could be used by women to simulate a man passenger in the car when they were driving alone. The ham version includes a digital recorder containing all the characters of the Morse code, and phrases such as, What's your QTH?; You're 20 over 9 at this end.; 73 and 88; The ARRL did what?; and short quips like: dipole; beam; hamfest. One option that you can activate is to have it say cus words (this must be for the retired military radio operators).

While there's no replacement for a real person, Good Buddy (unfortunately that's the name they gave to the ham model) can take away some of the loneliness of hamming alone. Just think of it; you're sitting there late at night and sitting beside you in a ham radio baseball cap and wearing a club sweater is your night time companion - Good Buddy. You push a button and he says "hear you loud and clear." Gives you shivers doesn't it? You'll never be alone again.

Good Buddy will be available for a short time because it will be on the shelves only on April 1. - K4MHM

FCC Investigating Texas Amateur

The FCC is investigating information indicating that Technician licensee Leonard Martin, KC5WHN, of Houston, Texas, operated outside of the amateur bands without a proper license. Field Office personnel in Houston reportedly monitored Martin and located him using direction-finding equipment on two occasions. On February 27, he was said to be operating on 27.535 MHz and 545 MHz. On March 15, he was said to be operating on 27.370 MHz, a frequency between CB channels.

FCC personnel, accompanied by local police, visited Martin on March 15, but he allegedly refused a request to inspect his station. The FCC's Riley

Hollingsworth, K4ZDH, says he has spoken with Martin, and the case is under review. "This subjects him to a large fine for unlicensed operation and refusal to allow an inspection, plus loss of his

license. "While these warning letters are a courtesy, we don't forget who we sent them to and it is a serious mistake not to take them to heart," Hollingsworth commented.

The FCC warned Martin in writing last November 3 about operation on frequencies other than those authorized under his Amateur Radio

In other actions, the FCC sent Warning Notices to an Illinois ham alleging broadcasting and on-air harassment as well as **transmission of profane and indecent language**. The FCC also warned a Texas ham about causing deliberate interference on 40 meters, an Illinois ham who holds a Technician ticket about operating on 20 and 40 meters, and a **North Carolina Novice** who's allegedly showed up on 2 meters. - *via ARRL Letter Online 3/26/99*

Submarines On The Air

The Submarine Veterans Amateur Radio Association will activate submarine radio rooms in late April to commemorate the anniversary of the submarine service. Upwards of 20 museum submarines in the US and overseas will be on the air the weekend of April 24-25 with volunteer operators. "Some of the museum boats have the radio rooms restored and operable with the original equipment," said Carl Raish, KG0HS, of the SVARA.

Stations will operate on or around 3943, 7243, 14,243, 21,313, and 28,343 kHz. A certificate of participation

is available for those obtaining at least four QSLs from submarines worked. The Submarine Veterans meet on the air daily except Sundays. Raish says the most popular on-air gathering is Saturdays, 1700 UTC on 14,243 kHz. This net



started about 25 years ago by World War II submarine veterans as a means of keeping in touch, and it has remained active ever since.

Vanity Call Sign Application Fee To Rise Slightly

The cost of applying for an amateur vanity call sign is expected to rise slightly this fall. In a just-released Notice of Proposed Rulemaking involving assessment and collection of regulatory fees for Fiscal Year 1999 (MD Docket 98-200), the FCC has proposed increasing the vanity fee to \$1.42 per year or \$14.20 for the 10-year term. The current vanity fee is \$13. It may be rounded off to \$14. - *via ARRL Letter*

FCC Fines Operators in Repeater QRM Case

The FCC has used mobile radio direction-finding techniques to solve a longstanding repeater interference problem. The Commission alleges that Michael Gallagher, KB3DHX, of Concord, Massachusetts, and Kornwell Chan, W3CI, of Dresher, Pennsylvania, were maliciously interfering with the Phil-Mont Mobile Radio Club 2-meter repeater, W3QV, and has levied fines on the two operators. On multiple occasions in February, personnel from the FCC's Philadelphia office traced radio transmissions to a vehicle said to be occupied by the operators in question. Both licensees have been issued Notices of Apparent Liability for \$7500.--FCC -

The FCC has set aside a new Technician grant to Raymond S. Graham, KC2EQQ, of Bronx, New York, while it evaluates allegations of earlier unlicensed radio operation. A letter to Graham March 11 from the FCC's Riley Hollingsworth noted that Graham had been formally warned about unlicensed operation on January 6. Graham's Technician license was issued February 17.--FCC - via ARRL Letter Online

The FCC has asked Joseph Walker, W8JCW, of Gaylord, Michigan, to retake his General and Advanced class amateur examinations under an ARRL-VE team. Walker must complete the retest by May 15. FCC'S Riley Hollingsworth Visits ARRL HQ

After six months as the FCC's top Amateur Radio enforcer, Riley Hollingsworth, K4ZDH, says he's pleased with the progress he's made and the support he's received from the amateur community. "I thought it would take a year or two years to be at this point," he told ARRL staff members March 17 during a visit to ARRL Headquarters. "We've had some very good enforcement luck."

Amateur Radio enforcement has been "one of the few victories the Commission has been having these days,"

Hollingsworth said, and he doesn't expect the impending FCC restructuring--including creation

of a new Enforcement Bureau--to affect its course or momentum. At the same time, Hollingsworth expressed some concern that his efforts not be perceived as the FCC "gone crazy" on Amateur Radio enforcement. "I don't want people saying, 'This is too much government,'" he said.

Hollingsworth said that enthusiasm for amateur enforcement has even spread to FCC field personnel, some of whom are hams and who now ask to be included in amateur cases. He pointed to a recent case of interference to a Pennsylvania repeater system that came out of an investigation at the field-office level.

Calling Amateur Radio "a great

natural resource," Hollingsworth said he felt privileged to be in his current enforcement role and was enjoying his work immensely. At this stage in the FCC's latest enforcement initiative, Hollingsworth says he's still making up for the FCC's "long period of neglect" of amateur enforcement. But he said he also looks forward to the day when he's no longer needed. He also said he can appreciate the frustrations of the Amateur Auxiliary during the years of FCC enforcement neglect and he welcomes their cooperation in the future.

In the weeks ahead, Hollingsworth said he hopes to turn his attention to such problems as the incursion of unlicensed operators on 10 meters--the so-called "freebanders" who often stray onto amateur frequencies--as well as the improper marketing of equipment to unlicensed individuals and examination fraud cases. He also plans to add some casual monitoring capabilities at his Gettysburg office. "If they know that we're out there bandsurfing, it will help," he said.

Hollingsworth said he's currently working about a month behind in replying and advised those contacting him to use either a letter or e-mail (rholling@fcc.gov) instead of the telephone.

ARRL officials and staff members were quick to praise

Hollingsworth's successes as well as his approach, which has been a combination of stern sanctions and "jawboning" with alleged offenders to resolve enforcement issues. As a result, he has not had to designate any amateur cases for hearings. "Few hams have the ability to change the hobby radically," ARRL First Vice President Steve Mendelsohn, W2ML, told Hollingsworth. "We're real fond of you." ARRL Educational Services Manager Rosalie White, WA1STO, called Hollingsworth "a huge breath of fresh air" for ham radio.

During his visit, Hollingsworth made a quick contact with an acquaintance on 20 meters from W1AW. He also had the rare opportunity to wield the original Wouff Hong and Rettysnitch--the traditional symbols manufactured and invoked by "The Old Man" during the early years of the hobby to combat poor operating practices. League officials expressed the hope that the experience would provide an additional boost to Hollingsworth's present-day enforcement

FCC Tackles HF "Splatter" Cases

The FCC has written nearly two dozen Amateur Radio licensees whose 20-meter SSB signals were said to be "unusually wide, overpowered, or both." The FCC's Riley Hollingsworth did not identify the specific licensees involved, but he said some of them were believed to be over-the-road truckers operating mobile. Licensees were in several locations, including Illinois, New York, Mississippi, Arkansas, Puerto Rico, Ohio, Kentucky, North Carolina and Florida. Hollingsworth's letter said information received by the FCC indicates that the stations involved "ignored requests from other licensees operating on adjacent frequencies" to do something about the wide signals. He said the operations in question were believed to be confined to the high end of the 20-meter band, above 14.300 MHz.

A letter from Hollingsworth to 22 Amateur Service licensees requests

fixed and mobile station information about the use of and specifications for any linear amplifiers employed on 20 meters as well as the use of automatic level control (ALC) and mike gain settings.

Hollingsworth cited Section 308 (b) of the Communications Act of 1934 as authority for the inquiry, calling it "our most powerful inquiry tool." He said the section "gives the Commission the authority to require information from a radio licensee during the term of the license that will enable it to determine whether that licensee is qualified to retain a license."

The affected licensees have 20 days to provide answers to the FCC.

Hollingsworth's letter pointed out that hams are prohibited from occupying more than the necessary amount of bandwidth for the particular mode and that hams must use the minimum power "necessary to carry out the desired communications."

replacement spectrum" to Amateur Radio and the Amateur Satellite Service in the event of a reallocation of primary amateur allocations, any reduction in secondary amateur allocations, or "additional allocations within such bands that would substantially reduce the utility thereof" to amateurs.

Mansfield said it's too soon to predict how HR 783 will fare in the new Congress, but said the fact that it has been introduced so early in the session "bodes well for our prospects." He said that a number of the cosponsors from last year already have indicated an interest in signing on again, "so I think we'll have a lot of support."

Mansfield also hopes the bill can take advantage of a desire on the part of the House leadership to move a lot of legislation through this year. "I'm hoping our bill will get caught up in their enthusiasm," he said.
