- A. The name of the Corporation is Dial Radio Club of the Middletown Area— W8BLV. The Corporation's original Articles of Incorporation were filed with the Secretary of State of the State of Ohio on March 17, 1976 pursuant to the Nonprofit Corporation Law of Ohio, Chapter 1702 of the Ohio Revised Code.
- B. The attached Amended and Restated Articles of Incorporation were duly adopted in accordance with the Section 1702.38(D) of the Ohio Revised Code and amend the previous Articles of Incorporation and all amendments thereto, superseding all provisions of the previous Articles of Incorporation and all amendments thereto.
- C. The text of the Resolution of Adopting the Amended and Restated Articles of Incorporation, including the text of the Articles of Incorporation as amended and restated, is attached hereto as Exhibit A.

# RESOLUTION ADOPTING AMENDED AND RESTATED ARTICLES OF INCORPORATION OF DIAL RADIO CLUB OF THE MIDDLETOWN AREA – W8BLV

NOW, THEREFORE, BE IT RESOLVED by the voting members of the Dial Radio Club of the Middletown Area - W8BLV, that:

- A. The following Amended and Restated Articles of Incorporation of the Dial Amateur Radio Association be and the same hereby are adopted pursuant to section 1702.38(D) of the Nonprofit Corporation Law of Ohio, Chapter 1702 of the Ohio Revised Code.
- B. The purpose of these Amended and Restated Articles of Incorporation of the Dial Amateur Radio Association is to amend the previous Articles of Incorporation and all amendments thereto of the Dial Radio Club of the Middletown Area W8BLV and to supersede all provisions of the previous Articles of Incorporation and all amendments thereto of the Dial Radio Club of the Middletown Area W8BLV.

# AMENDED AND RESTATED ARTICLES OF INCORPORATION OF DIAL RADIO CLUB OF THE MIDDLETOWN AREA – W8BLV

#### Article I

The name of the Corporation shall be Dial Radio Club of the Middletown Area - W8BLV.

#### Article II

The place in this state where the principal office of the Corporation is to be located is the City of Middletown, Butler County, Ohio.

#### Article III

The Corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### Article IV

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### Article V

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


